Dear Wateruser:

In July 2004, the Director of the Idaho Department of Water Resources (IDWR) issued an order requiring curtailment of diversions of ground water. Ground water users were ordered to cease diverting ground water because mitigation for depletions to the Big Lost River had not been provided as required by the Water Distribution Rules for Water District 34. On or about the day set for curtailment, plans of mitigation were offered and accepted by IDWR, and ground water users were able to continue pumping for the remainder of 2004.

IDWR anticipates the watermaster of Water District 34 will receive multiple requests for mitigation in 2005. IDWR wants to avoid the threat of curtailment during the 2005 irrigation season. Mitigation plans should be formulated early and be presented at the annual water district meeting in March 2005.

In order to assist in mitigation plan formulation, IDWR is sponsoring monthly public meetings to discuss mitigation and other water related issues. The purpose of each meeting is to present information about proposals for mitigation and for general operation of Water District no. 34, Big Lost River. The times and places of the meetings are as follows:

A discussion session must be scheduled with IDWR at least five (5) days before the evening meeting.

Discussion sessions will be open to all interested persons. Those requesting the discussion session will be the only vocal participants, however. Discussion sessions will be limited to 60 minutes. The content of each discussion session will be summarized at the evening meeting.
