Upon receipt of your Oath of Office, and a petition signed by one or more waterusers asking that you assume your duties, your Certificate of Appointment will be issued. A petition is not required if your duties are on an annual basis.

Enclosed are an Oath of Office form, and if needed, a Petition form for calling the watermaster to duty.

All Oaths of Office must be <u>signed</u>, <u>notarized</u> and <u>returned</u> to <u>this office</u> before Certificates of Appointment may be issued.
