Re: Notice of Potential Curtailment of Ground Water Rights Hydraulically Connected to the Snake River in the American Falls Area

Affected Right No(s): «rights»

Dear Water Right Holder:

This letter is provided to inform you that I am preparing a curtailment order for issuance on May 24, 2007, that may affect the above identified water right or rights. On or before that date I will make a determination of the extent of material injury reasonably likely to occur to members of the Surface Water Coalition during the 2007 irrigation season as a result of depletions caused by the diversion of water under junior-priority ground water rights. The order could result in the curtailment of consumptive ground water rights bearing priority dates junior to June 28, 1985, during the current irrigation season. The extent of material injury reasonably likely to occur during the 2007 irrigation season is currently projected at 58,913 acre-feet. Curtailment of an estimated 46,253 acres of irrigated land would be required to satisfy this projected shortage in surface water supply if no additional replacement water is provided as mitigation.

This priority administration of water rights is occurring as required by the Order of May 2, 2005, issued in response to the water delivery call made by members of the Surface Water Coalition, comprised of A&B Irrigation District, American Falls Reservoir District #2, Burley Irrigation District, Milner Irrigation District, Minidoka Irrigation District, North Side Canal Company, and Twin Falls Canal Company. The delivery call was made under the Department's Rules for Conjunctive Management of Surface and Ground Water Sources (IDAPA 37.03.11).

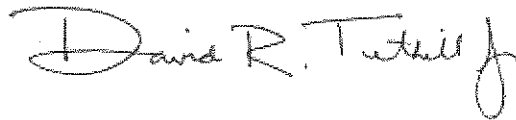
A curtailment order, if issued, will affect ground water rights for irrigation, commercial, industrial, municipal, non-exempt domestic use, and other consumptive uses. Non-consumptive uses and culinary in-house uses of water will not be subject to curtailment under the order.

CREP

Issuance of a curtailment order as described above, will affect the eligibility of land to be enrolled in the Conservation Reserve Enhancement Program (CREP). The United States Department of Agriculture (USDA) Farm Service Agency's rules for CREP require that "the cropland must be physically and legally capable of being irrigated in a normal manner when offered

for enrollment." Upon the issuance of a curtailment order, cropland irrigated with curtailed water rights is no longer "legally capable of being irrigated" and is therefore no longer eligible for CREP. Growers should also be aware that CREP is limited to an enrollment of 100,000 acres. For further CREP eligibility requirements, growers should seek advice from their local USDA Farm Service Agency office.

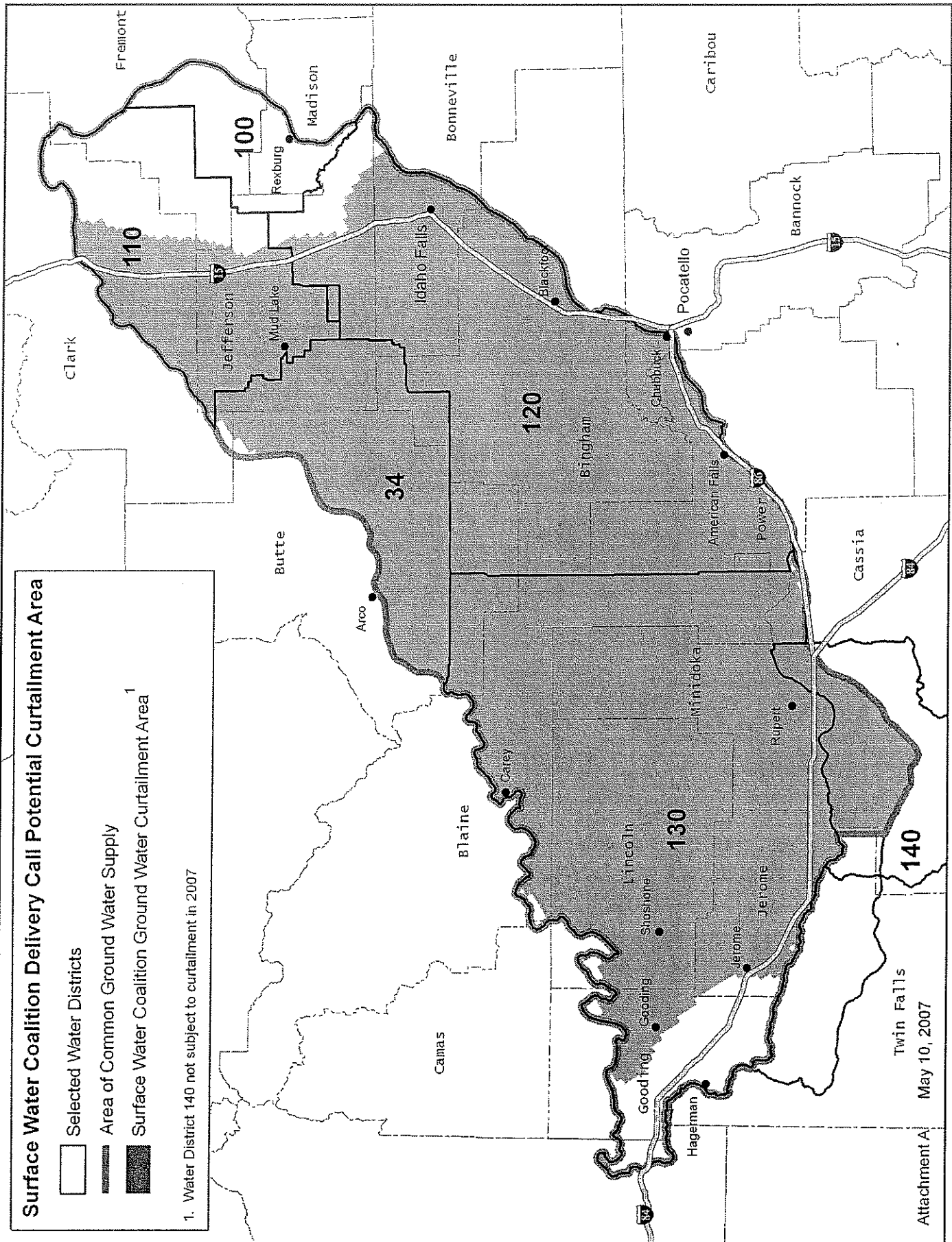

1. Water District 140 not subject to curtailment in 2007



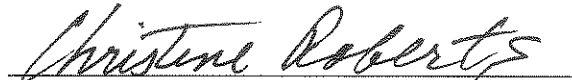
