The meeting for Little Canyon Creek Water District was called to order at 1:00 pm on 1/13/2003. The minutes of last year's meeting were read by Teresa McCalllum and were approved. All the officers were retained and Jim Allen was retained as watermaster.

We spoke a great deal about the measurement order. Rock Trail was concerned about the need for a measurement device above his reservoir. I told him I would do some research and that we would need to speak with Gary Spackman about the possibility of waiving that portion of the requirement. I have attached a memo written to Mr. Spackman with this meeting memo. We went over different types of measurement devices and which would be acceptable. I had copied a paper put out by Idaho Dept. of Water Resources (IDWR) on 2/20/1996 titled "Minimum Acceptable Standards for Measurement and Reporting of Surface and Ground Water Diversions." This paper helped to give the users some ideas of how and what type of devices would work best in their particular situations.

I spoke with the district concerning the new transfer memo, status of the Snake River Basin Adjudication (SRBA), and stream channel changes.

TRAIL RESERVOIR MEASUREMENT

Rocky Trail asked that I explain to you the measurement requirements for his diversion pond, and see if he could get the measurement requirement for the measurement above his reservoir waived. The Trail's have a small diversion pond (65 acre feet) that is used to build up water to divert into their main irrigation reservoir. The diversion pond was applied for under application for permit 61-7079, but was never licensed. A statutory claim was filed and recommended in the Snake River Basin Adjudication (SRBA) under water rights 61-4123C and 61-4123D. He is not opposed to the measurements of his diversion into his irrigation reservoir or the overflow at the diversion pond, but he does not understand the need for a measurement of the creek above his diversion pond.

I reviewed all of the information from water district files for Mr. Trail's reservoir and found the enclosed memorandum decision by Keith Higginson on 4/15/1971. This decision required the Trail's to measure the Little Canyon Creek above and below their diversion dam for water right 61-7079, but the two SRBA claims do not have this requirement. All conversations recorded in the files refer to this memorandum, and measurements that were made from a weir located above the diversion pond. The information in the Water District files suggests that this memorandum was implemented, even though 61-7079 wasn't licensed. I did not find any information approving the removal of this measurement requirement from the reservoir, or any information that would suggest that removing the measurement requirement would be acceptable.

The information does imply that this measurement is needed to ensure that Mr. Trail is releasing water from his diversion pond when he no longer has a right to store water and there is still water flowing in the creek above the pond. This requirement resulted in conflicts over the use of the diversion pond and was used after the permit lapsed. The measurement requirement has been used in the regulation of the reservoir in the past, and the tension in the area over water delivery suggests that this measurement requirement is still needed. I recommend that we require Mr. Trail to fix the existing device or install a new device in the creek. Mr. Trail stated that the existing device has not been checked in quite a while and he could not find the device. I would be open to any suggestions that Mr. Trail would have to circumvent installing a new device, but we need some means to measure the water going into and out of the diversion pond.

MEMORANDUM DECISION

On November 16, 1970, Lee T. Trail and Mary A. Blair submitted an Application for a permit to appropriate 65 acre-feet of water per annum at the rate of 13 cubic feet of water per second from Little Canyon Creek in Elmore County. The storage is for recreation and Fish Propogation and the maintenance of 65 acre-feet to facilitate irrigation of 633 acres within Sections 21 and 28, T. 58, R. 9E, B.M., in conjunction with other water rights held by the applicants. The lands described are included within the place of use under License No. 61-2228 (R-959), for the off-stream storage of 2532 acre-feet for irrigation purposes and License No. 61-2107 (25631), for diversion of water to the off-stream storage described in License No. 61-2228.

The water right developed under Licenses 61-2228 and 61-2107, in the opinion of the Department, allows the licensee to fill and utilize the diversion dam for diverting 2532 acre-feet per year to off-stream storage. However, it does not allow the licensee to maintain storage at the diversion dam during the times when no diversion is taking place under the above described licenses.

Application No. 61-7079 was filed to provide for maintenance of storage at the diversion dam during the irrigation season, subject to prior rights below the diversion.

Since the irrigation of lands described is covered by valid water rights to the extent provided by law, no additional rate of diversion of water to said lands may be allowed and the applicant should be authorized to store water at any rate that such water is available, subject to downstream prior rights, in order to fill the storage behind the diversion dam. It is also recognized that the 65 acre-feet requested will not be used for the actual physical application to irrigated crops, but is intended to provide a means of readily-diverting water to off-stream storage

when available under previous licenses and to provide water for fish, wildlife, and recreational purposes.

Therefore, it is hereby ordered and Application for Permit No. 61-7079 is approved only for the storage of 65 acre-feet of water, subject to the condition that measuring devices of a type approved by the Department be installed and maintained above and below the reservoir, and that any use of water under this permit be subject to the control and regulation of the Watermaster of Water District No. 61-D, Little Canyon Creek.
