 Report for the 65-K rental Pool: 337.9 acre feet of water was rented out. (report attached) There is an accumulated balance of \$1491.07 in the rental pool account. Herald stated that this money may be used for maintenance in 65K district. John suggested that the weir on the Cruzen ditch does need fixed.
Other Business: Cynthia is our new contact with the IDWR, and the new dam inspector. John stated that the water situation looks good and the boards are all in and the gate closed.

10. With no further business, Herald motioned to adjourn the meeting. Justin 2nd the motion. The meeting adjourned at 1:30p.m.
