The Director of the Idaho Department of Water Resources ("Director") is authorized to divide the state into water districts for the purpose of distributing water among appropriators under the laws of the State of Idaho. Section 42-604, Idaho Code provides authority for the Director to create, revise the boundaries of, or abolish a water district or combine two (2) or more water districts.

NOTICE IS HEREBY GIVEN, pursuant to Section 42-604, Idaho Code, that the Idaho Department of Water Resources (IDWR) will conduct a public hearing regarding the expansion of Water District No 29, Portneuf River and tributaries, as follows:

PUBLIC HEARING FOR PROPOSED EXPANSION OF WATER DISTRICT NO 29:

**3:00 PM, March 2, 2009 at the Lava Community Building,
150 North Center (off Highway 30)
Lava Hot Springs, ID.**

The hearing will immediately follow the regular annual Water District 29 meeting which is scheduled to begin at 2:00 p.m. on the same date and at the same facility.

IDWR proposes expansion of Water District No. 29 to include the Portneuf River and tributary sources between the confluence of Harkness Creek and the Portneuf River near McCammon, Idaho, downstream to the confluence of the Portneuf River and Marsh Creek near Inkorn, Idaho. IDWR further proposes to expand Water District No. 29 to include Indian Creek, which sinks near Inkorn, Idaho prior to reaching the Portneuf River.

The expansion of the water district is proposed in response to requests by water users owning water rights diverted from Indian Creek and several streams tributary to the Portneuf River in the vicinity between McCammon and Inkorn, Idaho. Administration of water rights in Water District No. 29 has historically been limited to the Portneuf River and tributaries upstream of McCammon, Idaho, including Harkness Creek. Extending Water District No. 29 to include these additional water sources is required in order to properly administer the water uses and water rights from these sources.

Information and testimony presented at the hearing on March 2nd will create a record upon which the Director will rely to determine whether expanding the water district is appropriate. It is important that holders of water rights understand the proposed action and participate in the hearing. IDWR Water Management Division Administrator, Gary Spackman, will serve as the hearing officer. Persons attending the hearing will be provided an opportunity to make an oral presentation regarding the creation of the proposed district. Written comments may be submitted to the hearing officer at the hearing or at any time prior to the close of the written comment period on March 12, 2009. Written comments not presented at the hearing should be sent to the Director, Department of Water Resources, PO Box 83720, Boise, Idaho, 83720-0098.

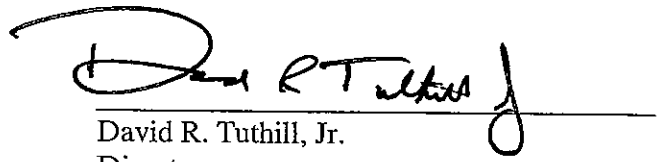

This notice of hearing has been sent to all surface water right holders of record in Water District No. 29 and holders of water rights with sources from Indian Creek, and the Portneuf River and tributaries between the confluence of Harkness Creek and the Portneuf River near McCammon, Idaho, downstream to the confluence of the Portneuf River and Marsh Creek near Inkom, Idaho.
