1	DIRECTOR DREHER: Good evening, my name is Karl J.Dreher, I am the Director of
2	the Idaho Department of Water Resources. I'm serving as the presiding officer in
3	the this matter and this matter concerns the proposed creation of a water district
4	for a portion of the Eastern Snake Plain Aquifer within the departments
5	administrative basins 21 & 22.
6	
7	The provisions of Idaho Code § 42-604 require this hearing to be held prior to the
8	creation of a water district by the person in my position.
9	
10	The hearing is being conducted on November 14, 2006, commencing at about
11	8:45 p.m. at the Best Western Cotton Tree Inn, located at 450 West 4 th South St.
12	in Rexburg, Idaho. Actually we are in the Chamber of Commerce building,
13	adjacent to the Hotel.
14	
15	The purpose of this hearing is to provide affected water right holders or their
16	representatives, an opportunity to make a verbal statement on the record stating
17	their position, views, or concerns regarding the creation of the proposed water
18	district.
19	
20	For the purposes of this hearing, persons making statements do not need to be
21	sworn, nor will they be subject to cross-examination. All persons signing up to
22	speak will be heard before others are heard, but in the event there are other people
23	that initially did not want to speak but then later do wish to speak, they will be
24	heard as well, once everyone that signed up has been given the opportunity, and
25	again, if there is somebody that wants to make a follow up statement, that will be
26	provided as well, once everyone has had an opportunity to speak first.
27	
28	Notice of this hearing was mailed to each affected water user in the proposed
29	district as required under the provisions of Idaho Code § 42-604. In addition,
30	notice was published in the Post Register, that's the paper in Idaho Falls and the
31	Rexburg Standard Journal. These are both newspapers of general circulation
32	within the area of the proposed district.
33	
34	I've spent a considerable time making preliminary statements and answering
35	questions. We are now at the point where we may begin taking statements and
36	comments from those persons who desire to be heard in this proceeding. So, we
37	will start in the order that people signed up and we will start with Mr. Jeff
38	Raybold, and Jeff before you proceed if you will state your full name and address
39	and identify that you are speaking on behalf of the Freemont Madison Irrigation
40	District.

The 106 hearing record for this matter will remain open for 10 days, through November 107 24, 2006, to allow time for the submittal of any additional written comments that 108 you would like to provide and of course this was also provided in the notice of 109 this proceeding and is also required by Idaho Code 42-604. Once the comment 110 period is closed, I will issue a final order. A copy of the final Order will be sent 111 by regular mail to all holders of water rights affected by the order, and as I 112 indicated before we went on to the record, any party that believes that my actions 113 are incorrect or they believe they are grieved by them, they can file a petition with 114 me for reconsideration within 14 days of the date of service of the Order, and 115 beyond that, any party feeling grieved by the final Order may also seek judicial 116 review before a District Court within 28 days of the issuance of the final order or 117 within 28 days of any action taken on a petition for reconsideration. Thank you 118 all for attending tonight and the record is now closed except for the taking of 119 additional written comment as I've described. Thank You. 120
