The first Upper Salmon Water District Steering Committee is scheduled as follows:

The purpose of this first meeting is to discuss why the Idaho Department of Water Resources ("IDWR") is proposing creation of the Upper Salmon Water District, the scope of the water district, timeline for creation of the district, and requirements of the district. We also hope to begin discussing district organization and governance. A proposed meeting agenda is attached.

A steering committee is needed to help water users prepare for the first annual water district meeting. The first annual water district meeting will likely be held in March or April of 2006, pending a final order issued by the Director of IDWR, and pursuant to a hearing held by the Director IDWR anticipates the steering committee will draft proposed resolutions for the first annual meeting regarding election of a watermaster, advisory committee, and treasurer; proposed budget, collection of budget; and other resolutions pertinent to the operation of the district. The first steering committee meeting will be informal and informational in nature. IDWR does not expect the steering committee to begin addressing water district resolutions until the second or third steering committee meeting.

A copy of the current steering committee roster is also included with this letter. The committee representation is similar to what IDWR proposed in its last correspondence dated June 17, 2005. There are a total of 15 committee members listed, including two Idaho legislative representatives. All of the individuals listed accepted invitations and/or expressed interest in participating in the committee. Some additional water users and interested individuals also expressed a desire to participate on the committee. IDWR invites these additional interested parties to participate in all steering committee meetings through the steering committee. A list of other interested parties who responded to IDWR's June 17th letter and

asked to be considered for inclusion on the committee is also attached to this letter. The current committee and meeting participants can discuss or consider changes to the committee.
