On February 20, 2007, the Director of the Idaho Department of Water Resources issued an order requiring controlling works and measuring devices in Water District No. 170. This order was mailed to you on February 20, 2007. The order included an attachment (Attachment A) listing points of diversions in administrative basin 71 that must comply with the requirements of the order. Points of diversion that must comply with the requirements of the order are those divert more than 0.24 cfs or irrigate 5 acres or more. Six points of diversion that meet this criterion were inadvertently left off the list. These six diversions and their associated water rights and owners are listed on the attached table. These six diversions must comply with the requirements of the February 20, 2007 order requiring controlling works and measuring devices in Water District No. 170.

The order requires plans to be submitted to IDWR by June 1, 2007 and requires functioning control works and measuring devices prior to diversion of water during the 2008 irrigation season. However, as these six diversions were not included in the February 20, 2007 mailing, the deadline to submit plans for these six diversions is June 20, 2007. Re: Letter of February 27, 2007 regarding diversions from the Salmon River

Greetings:

This letter responds to Mr. and Mrs. Rodgers' letter of February 27, 2007. The letter indicated that the Rodgers and the Rosenkrances should be exempted from the order requiring headgates and measuring devices in Water District No. 170. The letter explained that the two users divert water from separate pumps, and that each diversion is below the threshold described in the order.

I visited the two properties on March 8, 2007 and verified that the two properties are irrigated from separate pumps. I marked the diversions with an IDWR-issued site tag and recorded their positions using a global positioning device. I have updated IDWR's database records to reflect the separate diversions.

Since each diversion is below the threshold described in the order, the diversions for water rights 72-74545, 72-7457, and 72-7458, located in the NW quarter of the SW quarter of Section 28, Township 13N, Range 19E, are exempt from the requirements of the February 20, 2007 order requiring controlling works and measuring devices in Water District No. 170.
