Re: Letter of Complaint

Dear Mr. Pugh:

Our office was forwarded your recent letter to the Department's State Office regarding the problem you are experiencing with your well. Your well problem sounds serious and the Department is taking steps to look into this matter.

Your letter is not currently being considered as a delivery call as defined in the "Rules Governing Conjunctive Management of Surface and Ground Water" (IDAPA 37.03.11) subject to the "Rules of Procedure" (IDAPA 37.01.01); however, in response to your letter the ground water hydrology staff at the state office has been requested to investigate this matter. Your letter alleges that the recently developed well for Avenmore (Glanbia) has caused your well to go dry. Preliminary review of well records for the area finds that your well is approximately 2.75 miles to the west of the Glanbia well and that there are wells in the area between your well and the Glanbia well. It would be peculiar that the Glanbia well would not affect these other wells but directly affect your well. An initial contact with Glanbia indicates that they understood your well may have dried up before the Glanbia well was turned on. This understanding conflicts with the statement in your letter. Any additional detailed information you may have regarding affects on other wells or the details of the timing of events regarding your well problems and the use of the Glanbia well or other wells in the area would help clarify issues and may aid in the hydrology staff review. Please submit any additional information to this office as soon as possible.

As you may know, the Glanbia well was the subject of a contested application for a water right permit. This contested case ultimately went to a formal hearing where evidence and testimony was taken and considered by the Department in approval of the Glanbia permit No. 37-21136. Part of the hearing record included evidence of a pump test of the Glanbia well that predicted drawdown characteristics for the well. The prediction was that the Glanbia well would not cause problems with your well some 2.75 miles away. The water


right hearing process has been established to avoid injury to existing water users. Once uses are established sometimes effects unpredicted may occur.

Currently the Department lacks sufficient detailed information to make a determination of the cause for your well problem.

Several years ago the Department administered a "drought relief" program that provided monetary assistance to well owners to replace or modify drought-affected wells. This program has not been funded for several years. I understand that there exists a similar "emergency conservation program" currently administered by your local USDA Farm Service Agency. I understand that this is a cost sharing program (50% to 64%) and that certain limitations apply. Funding is also an issue for this program. I understand that funds are not currently available, but funding may be available after Labor Day if the county qualifies under USDA criteria. I recommend that you contact your local USDA Farm Service office for details. Unfortunately, I know of no other assistance programs.

Once our hydrology staff completes their investigation you will be sent a copy of their results. By copy of this letter and copy of your initial letter I am informing Glanbia of the issue at hand. I welcome any factual information they may provide to assist our hydrology staff in reviewing this situation.

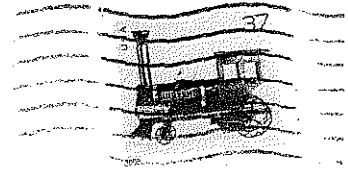
