

- 1.) Compile a list of all surface water Permits and Licenses (excluding Hydro Power) within Basins 37 & 37M that have Conditions of Use with Watermaster authority.
- 2.) Query the list developed by SPF Engineering and organized by Daniel Nelson to show wells that have both ground water and surface water in the same well. (Example 37-7775D with 37-604E or 37-7064E with 37-102b). I'm wondering whether these wells would be allowed to keep running even if the surface priority has be shut off, because the ground water right is not regulated. Or, are the groundwater rights supplemental and should therefore be shut off with the surface water? The list is an excellent tool from which to start, but I'm finding some diversions that need further explanation.
- 3.) Identify total deliveries by priority to the following canals:
 - a.) Bannon 49
 - b.) Baseline #55C
 - c.) Black 61
 - d.) Cove #33
 - e.) District 45
 - f.) Glendale 50
 - g.) Hiawatha #22

4.) How much of the old "Hiawatha Flood Water" Decree was claimed in the SRBA? The decree numbers are 37-896 thru 37-923. The original decree has some confusing language about priority of delivery. It looks like one of those "saved water" decrees, but I've never delivered it that way. I believe Brockway Engineering claimed a piece of this for Rinker and Co., so I will need some guidance on how this will be delivered.

If you could add these responses to the other twelve issues we have discussed, I would really appreciate it.
