Therefore, such territory is hereby declared duly organized as an irrigation district under the name and boundaries designated in the Petition.

IT IS FURTHER ORDERED THAT one copy of this Order shall be duly certified and filed for the record in the office of the Blaine County Recorder, and one certified copy of this Order shall be transmitted to the Governor.

IT IS FURTHER ORDERED THAT from and after the date of the filing of said Order of the Board of County Commissioners declaring such territory duly organized as a irrigation district, the organization of such district shall be complete and subject to the requirements of Idaho law.
