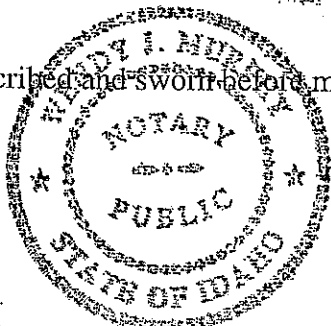

Minutes of Annual Meeting

Water District No.110
Annual Meeting Minutes
February 13, 2008

Kirk Jacobs called the meeting to order at 1:05 pm. Lyle Swank, Blake Jordan, Tim Luke, Wendy Murphy, Ernie Carlsen and Lisa Purvis from IDWR and Treasurer Dale Rockwood were present. There were approximately 27 other meeting attendees, including advisory members Don Parker, Darren Bitter, Kirk Jacobs, Scott Clawson and Mike Cope.

Don Parker moved to have Kirk Jacobs act as meeting chairperson, Darren Bitter seconded the motion, and it carried without dissent. Don Parker moved to have Lisa Purvis act as meeting secretary, Darren Bitter seconded the motion, and motion was passed.

Don Parker read the 2007 Annual meeting minutes. Darren Bitter motioned to accept the minutes as read, Carl Ball seconded the motion and it was passed.

Dale Rockwood, the treasurer presented the financial report. Don Parker moved to accept the financial report, Darren Bitter seconded and the motion passed.

Tim Luke, manager of the water district section for the State of Idaho, presented the IDWR report. This is the third year of operations for Water District 110. Decreed water rights were reviewed, and ground was identified as irrigating without a water right. This resulted in approximately 30 Notices of Violations (NOV) being sent last spring. Some claims have been resolved with filing late claims, transfers, and stopping irrigation of acres without water rights. NOV's will continue to go out annually. Magic Valley had 12 out of compliance when they first started sending NOV's, however, compliance increased over time. The purpose of the NOV is to bring water users in compliance with their water right.

Other issues discussed included the A & B Irrigation complaint in 1994 or 1995 that the state did not enforce water rights and that the purpose of the Water District is to monitor delivery, measurement reporting, diverting and unauthorized use. Idaho Code Section 42:620 said that the water district had to pay for monitoring expenses. Legislature proposed \$20 million to fund the aquifer study portion and covers the monitoring expenses the water users were anticipated spending.

Judge Schroder will be issuing an order in 4 to 6 weeks for the Surface Water Coalition Call. Tim feels that his decision will be fair. An order was issued on January 29 for the A & B call; it was favorable to ground water users and didn't find material injury. This case has been appealed and there will be a hearing in May. These cases will probably go to the Supreme Court. Kirk Jacobs said that IGWA has taken an active role in defending the water rights of ground water users.

Lyle Swank stated that he is an advocate for water users and he likes to get the water holders point of view. He stated the IDWR provides water districts with lots of expertise such as, accounting, water use measurements, transfers, weir designs, GIS imagery, and a working relationship with other water districts.

Blake Jordan presented his portion of the watermaster report. The water outlook is at 45.3% of capacity. It was 71% in 2007 at this same time. It has been a colder winter than normal and there has been no run off yet. The snow water equivalent is a little above average. In 2007 there were 264 site visits and 260 were measured. The measurements breakdown is as follows: 247 PCC, 4 Flow meters, 1 Time clock, 1 alternative, 9 unused and 2 waived. Protocol is to measure 1/3 of the wells each year, which was met. There are 746 POD in WD110, 1/3 of these would be 249. Blake presented "Percent of Water Used" chart, "Depth to Water Report" and "Water Level Trend Line" chart. Goals for 2008 are to re-visit/re-measure questionable data and wells measured in 2005 and those missed in 2007.

Kirk Jacobs indicated the board approved Ernie Carlsen as Watermaster. Kirk said the department has been without flaw on measuring. The committee reviewed proposals from IDWR and Water Well Consultants for measurement services. Scott Clawson indicated the group's decision was based on two concerns. First concern was separation of power concept and work from the department. Second concern was time and monetary.

Kirk Jacobs reviewed the resolutions. The following changes were made to the 2008 resolutions:

- Resolution #2, Lyle Swank was replaced by Ernie Carlsen to provide watermaster services. Scott Clawson motioned to accept the change, Don Parker seconded the motion, and the motion passed.
- Resolution 4, the first paragraph was deleted.
- Resolution 4 a) IDWR was changed to WD110.
- Resolution 4b), delete "is limited" and put in "includes".
- Resolution 4c), delete "where such services are related to activities and expense for measurement and reporting of diversions only".
- Delete resolution #9.
- Resolution #5 add, "but will pay a pro rata portion of the watermaster salary".

Don Parker proposed that CAMAS National Wildlife be refunded the \$25 per diversion charge is has paid during 2006 and 2007 because of Resolution 5. Rob Larranaga, from CAMAS, agreed that the \$25 he has paid in the past could be credited to their future bill. Carl Ball moved to accept the resolutions with changes and Don Parker seconded the motion. The motion passed.

Wendy Murphy presented the budget for 2008. The income in the budget was changed use reserve funds. Carl Ball motioned to approve the budget, with changes, and Don Parker seconded the motion. Motion was passed.

Karl Ball motioned to keep the same advisory committee members. Wayne Torgerson seconded the motion and the motion carried.

Approved Resolutions

**Water District 110
2008 Resolutions**

1. That the watermaster perform the duties as required by Chapter 6, Title 42, Idaho Code and in accordance with:
 - 1) The duties described in the Final Order Creating Water District 110, signed by the Director of the Idaho Department of Water Resources (IDWR), April 17, 2006, including:
 - a) Measure, record and report diversions of ground water right included in Water District NO. 110;
 - b) Administer and enforce water rights in Water District No. 110 in priority;
 - c) Curtail unauthorized or excessive diversions in Water District No. 110 (i.e., any diversion without a water right or in excess of the elements or conditions of a water right);
 - d) Curtail out-of-priority diversions under ground water rights in Water District No. 110 determined by the Director to be causing injury to senior priority water rights if not covered by a stipulated agreement or a mitigation plan approved by the Director;
 - e) Enforce the provisions of any stipulated agreements or mitigation plans approved by the Director and applicable in Water District No. 110.
 - 2) Direction and guidance provided by the Director of IDWR pursuant to Idaho Water Law.
 - 3) The annual water district resolutions as adopted herein.
2. Ernie Carlsen be elected the watermaster for Water District 110. That the Director of IDWR appoints Ernie Carlsen an employee of IDWR, to provide watermaster services for the ensuing year.
3. As provided in Idaho Code § 42-608(4), the watermaster shall serve until the next annual meeting of the water district after election at this meeting and upon appointment by the Director.
4. The water users of Water District No. 110 hereby empower the elected advisory committee to enter into a Memorandum of Understanding between Water District No. 110, and the Director of IDWR that will provide for the following:
 - a) IDWR will provide compensation of the watermaster for all administrative watermaster duties (all duties other than measurement and reporting) for the term of service as specified in item 3 of these resolutions.
 - b) The 2008 budget for Water District No. 110 is limited to expenses related to measurement and reporting, and will be set at this annual meeting in accordance with item 7 of these resolutions.

- c) Water District No. 110 will provide compensation to IDWR for clerical and financial account support services, where such services are related to activities and expenses for measurement and reporting of diversions only.
 - d) The watermaster shall maintain an office for the ensuing year within the IDWR Eastern Regional Office, located in Idaho Falls, Idaho.
 - e) IDWR will provide office space, vehicles and the use of all necessary office and field equipment in exchange for compensation as set in the budget for the ensuing year. This arrangement shall not give Water District No. 110 any ownership interest in any IDWR office space and equipment.
5. Water District No. 110 includes one or more canal companies, government entities, or other water delivery entities. The following canal companies and government entities had cooperative agreements or other arrangements with the North Water Measurement District to annually measure and report diversions on their own and to the measurement district in order to promote efficiency in the administration of water rights and water management.
- 1) Montevue Canal Company
 - 2) Producers Canal Company
 - 3) Jefferson Irrigation Company
 - 4) United States Fish & Wildlife Service Camas National Wildlife Refuge
6. The entities designated above may have employees who measure and report diversions to the water master of Water District No. 110. The water master of Water District No. 110 may therefore appoint employees or agents of these entities as assistant watermasters for purposes of measuring and reporting water use to the watermaster of Water District No. 110. The water district watermaster and the Director of IDWR will provide direction and guidance to assistant watermasters for measuring and reporting of diversions in these entities, including but not limited to the following:
- a) Each entity responsible for data collection shall provide an annual report of diversion data to the water district watermaster in accordance with Idaho Code § 42-606, § 42-708, § 42-709, and the direction provided by the Director of IDWR.
 - b) Assistant watermasters shall cooperate and coordinate with the water district watermaster and IDWR in sharing water use information.
 - c) The regulation of diversions, including curtailment of diversions and other water right enforcement actions, shall be the primary responsibility of the water district watermaster and IDWR.
 - d) The designated districts will first be given the opportunity to resolve unauthorized diversions, or other enforcement matters before action is taken by the watermaster or IDWR.

- e) To the extent that assistant watermasters may otherwise be involved in the regulation or enforcement of diversions, such involvement will be under the instruction of the watermaster and the Director of IDWR.
7. The budget of Water District No. 110 for the fiscal year 2008 beginning February 1, 2008, and ending on January 31, 2009, be as follows:
- See attached Budget
8. Assessment basis for measurement & reporting expenses: Diversions in Water District 110 that are not already measured by one of the canal companies or government entities identified in item 5 of these resolutions, and also have a diversion rate allowed by their water right in excess of 0.24 cfs and/or irrigation of more than five acres shall be measured directly by the water district in the ensuing year and assessed for measuring and reporting at the following rate;
- a) \$25 per diversion, and;
 - b) A pro-rata share of the total expense for measuring and reporting, minus the total amount charged for all the diversions in the district required to measure, determined by the fraction of the recorded diversion rate for each water right is to the total recorded diversion rate of all water rights being measured in the district.
9. All water users in Water District 110 will be billed their prorated share of the ESPA program and monitoring costs based on their water right as stated in Idaho Code § 42-612.
10. Dale Rockwood be elected Water District No. 110 Treasurer. The duties of the treasurer will be to approve the expenses and disburse water district funds, and to prepare or oversee preparation of a written statement of the financial affairs of the district at the end of each fiscal year, in accordance with Idaho Code, Section 42-619.
11. An advisory committee shall be elected at each regular annual session to represent the interests of the water users and to provide input to the watermaster and the Director of IDWR. The advisory committee will consist of two water users from Hamer, two water users from Montevue, and two from Mud Lake/Terreton Area.
12. WHEREAS Idaho Code 42-605 provides for voting by water users and election of an advisory committee, the water users of Water District No. 110 hereby resolve that the credentials for voting in any district meeting and for serving on the district advisory committee will be as follows:
- a) Must be a water user of the district as evidenced by a valid water right or
 - b) Must have paid all assessments owed to the water district.

13. The annual Water District No. 110 meeting shall hereafter be held on the second Wednesday of February, of each year unless the Director of IDWR or the Water District No. 110 advisory committee should find it necessary to change the meeting date or unless changed by resolution of the district at any annual meeting.
14. Copies of the minutes of the annual meeting, the budget as approved, all resolutions approved, and the report prepared in accordance with Idaho Code § 42-615, shall be filed with the director of the Department of Water Resources in accordance with Idaho Code § 42-617.
15. The watermaster of Water District No. 110 shall be responsible for submitting to IDWR annual reports showing water use and such other information that may be deemed necessary by the Director of IDWR in accordance with Idaho Code § 42-606, § 42-708, and § 42-709.
16. The watermaster and assistant watermasters are authorized under Idaho Code § 42-1701(5) to make reasonable entry on lands within the district to carry out the duties of the watermaster as instructed by IDWR. These duties include but are not limited to:
 - a) Monitoring diversion and measuring rate and volume of water diverted from ground water and other public water sources.
 - b) Measuring the depth to water in wells.
 - c) Monitoring the place, period, and nature of use of water to identify unauthorized diversion and use and to determine compliance with mitigation provisions required by agreement or order of IDWR.
17. HEREBY BE IT RESOLVED, that Water District 110 advisory committee shall be charged with the responsibility for the appointment of member(s) to serve as advisor(s) to the Eastern Snake Plain Aquifer Monitoring Committee as defined by Idaho Code § 42-620.
18. All payments for assessments not received by May 1, 2008 shall accrue penalties in the amount of 10% of the charge and interest in the amount of 1% per month, as provided pursuant to Idaho Code § 42-617.
19. Be it also resolved, that the Watermaster is authorized pursuant to Idaho Code § 42-618, to withhold or suspend deliveries of water to any water users who have not paid their assessment charge by January 1 of the year following the billing date.

CASH AND CASH EQUIVALENTS

Cash and cash equivalents are identified as cash and short-term, highly liquid investments. Cash and cash equivalents for the District include cash in checking and savings accounts.

INVENTORY

Inventories are valued at cost. The purchase method is used to account for inventories. Under the purchase method, inventories are recorded as expenditures when purchased; however, material amounts of inventories are reported as an asset at year end.

CAPITAL ASSETS

Capital assets, which include property and equipment, are recorded at cost. Depreciation is provided using the straight-line method over the estimated useful life of the asset, which is five to ten years for assets of the District. Depreciation of fixed assets is charged as an expense against operations. Capital assets are reported net of accumulated depreciation on the statement of net assets. When an asset is disposed of, cost and related accumulated depreciation are removed from the District's financial statements, and any gain or loss arising from the asset's disposal is credited or charged to operations. The cost of normal maintenance and repairs that do not add to the value of the asset or materially extend the asset's life are not capitalized.

USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

POLICY FOR USE OF RESTRICTED AND UNRESTRICTED RESOURCES

The District's policy is to first apply unrestricted resources when an expense is incurred for purposes for which both restricted and unrestricted net assets are available.

NOTE 2: DEPOSITS AND INVESTMENTS

Deposits: Custodial credit risk, in the case of deposits, is the risk that in the event of a bank failure, the District's deposits may not be returned to it. The District has no deposit policy for custodial credit risk. At year end, none of the District's bank deposits were exposed to custodial credit risk due to being uninsured and uncollateralized.

Investments: Custodial credit risk, in the case of investments, is the risk that in the event of the failure of the counterparty, the District will not be able to recover the value of its investments or collateral securities that are in the possession of an outside party. At year end, the District held no investments.

The statement of net assets presents the financial condition of the business-type activities for the District at year-end. The statement of activities presents a comparison between direct expenses and program revenues for each program or function of the District's business-type activities. The statement of activities demonstrates the degree to which the direct expenses of a given function or segment are offset by program revenues. Direct expenses are those that are clearly identifiable with a specific function or segment. Program revenues include 1) charges to customers or applicants who purchase, use, or directly benefit from goods, services, or privileges provided by a given function or segment and 2) grants and contributions that are restricted to meeting the operational or capital requirements of a particular function or segment. Other items not properly included among program revenues are reported instead as general revenues.

FUND FINANCIAL STATEMENTS

Separate financial statements are provided for the different funds maintained by the District. Individual "major" funds are reported as separate columns in the fund financial statements.

**MEASUREMENT FOCUS, BASIS OF ACCOUNTING, AND
FINANCIAL STATEMENT PRESENTATION**

The government-wide financial statements and the proprietary funds are reported using the economic resources measurement focus and the accrual basis of accounting. Revenues are recorded when earned and expenses are recorded when a liability is incurred, regardless of the timing of related cash flows. Grants and similar items are recognized as revenue as soon as all eligibility requirements imposed by the provider have been met.

The District reports the following major proprietary funds:

The Water District Operating Fund. It accounts for the general operations of the District.

Amounts reported as program revenues include charges to customers for goods and services, operating grants and contributions, and capital grants and contributions.

Proprietary funds distinguish operating revenues and expenses from nonoperating items. Operating revenues and expenses generally result from providing services and producing and delivering goods in connection with a proprietary fund's principal ongoing operations. The principal operating revenues of the proprietary funds are charges to customers for sales and services. Operating expenses for enterprise funds include the cost of sales and services, administrative expenses, and depreciation on capital assets. All revenues and expenses not meeting this definition are reported as nonoperating revenues and expenses.

BUDGETS

The District adopts a budget for the Operating Fund at the annual meeting. The budget is prepared on a basis generally consistent with generally accepted accounting principles, except that expenses for capital acquisitions are budgeted. The reported operating expense amounts exclude actual capital acquisitions since they are capitalized and depreciated.

NOTE 1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

REPORTING ENTITY

Water Districts were established in 1903 by the Idaho Legislature with the duty of directing and controlling the distributions of water within each District assigned to the State Reclamation Engineer (later changed to the Idaho Department of Water Resources). The Idaho Code was amended in 1986 to clarify the status of the Districts in that each shall be "considered an instrumentality of the State of Idaho".

Water District 110 is governed by the Director of the Idaho Department of Water Resources who appoints the Watermaster. The Watermaster is elected by the members of Water District 110 at their annual meeting. During the annual meeting members adopt various resolutions governing the activities of the District.

Water District 110 is responsible to the Director of the Department of Water Resources and water right holders of the District to make proper distribution of available water supplies within the District as appropriated.

In evaluating how to define the Water District for financial reporting purposes, management has considered all potential component units. The decision to include a potential component unit in the reporting entity was made by applying the criteria set forth in Generally Accepted Accounting Principles. The basic, but not the only, criterion for including a potential component unit within the reporting entity is the governing body's ability to exercise oversight responsibility. The most significant manifestation of this ability is financial interdependency. Other manifestations of the ability to exercise oversight responsibility include, but are not limited to, the selection of governing authority, the designation of management, the ability to significantly influence operations and accountability for fiscal matters. The other criterion used to evaluate potential component units for inclusion or exclusion from the reporting entity is the existence of special financing relationships, regardless of whether the Water District is able to exercise oversight responsibilities.

Based upon the application of these criteria, there are no component units to be included in the financial statement presentation of Water District 110.

GOVERNMENT-WIDE FINANCIAL STATEMENTS

The government-wide financial statements, which are the statement of net assets and the statement of activities, report information on all of the nonfiduciary activities of the primary government. Water District 110 reports only business-type activities, which rely to a significant extent on fees and charges for support, and has no governmental or fiduciary activities.

Credit Risk: The District's policy is to comply with Idaho State statutes which authorize the District to invest in obligations of the United States, obligations of the State or any taxing district in the State, obligations issued by the Farm Credit System, obligations of public corporations of the State of Idaho, repurchase agreements, tax anticipation notes of the State or taxing district in the State, time deposits, savings deposits, revenue bonds of institutions of higher education, and the State Treasurer's Pool and Diversified Bond Fund.

NOTE 3: ASSESSMENTS RECEIVABLE

Assessments are billed at the end of the water year in the spring. No allowance for uncollectible accounts has been recorded, as the District believes all assessments can reasonably be expected to be collected.

NOTE 4: CAPITAL ASSETS

The district has no capital assets.

NOTE 5: LONG-TERM LIABILITIES

The District had no long-term liabilities as of January 31, 2009

NOTE 6: LITIGATION, CONTINGENT LIABILITIES AND COMMITMENTS

The District is not aware of any pending or threatened litigation against the District as of January 31, 2009.

NOTE 7: RISK MANAGEMENT/INSURANCE COVERAGE

The District is subject to various risks of loss related to tort claims; theft, damage to and destruction of assets; errors and omissions; injuries to employees; and natural disasters. The Treasurer is bonded for errors and omissions. As an instrumentality of the State of Idaho, other risks of loss are covered by the State's liability insurance policy.

We have audited the accompanying financial statements of the business-type activities and each major fund of Water District 110 (the "District"), as of and for the year ended January 31, 2009, which collectively comprise the District's basic financial statements and have issued our report thereon dated May 11, 2009. We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States.

Internal Control Over Financial Reporting

In planning and performing our audit, we considered the District's internal control over financial reporting as a basis for designing our auditing procedures for the purpose of expressing our opinions on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the District's internal control over financial reporting. Accordingly, we do not express an opinion on the effectiveness of the District's internal control over financial reporting.

A control deficiency exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent or detect misstatements on a timely basis. A significant deficiency is a control deficiency, or combination of control deficiencies, that adversely affects the District's ability to initiate, authorize, record, process, or report financial data reliably in accordance with generally accepted accounting principles such that there is more than a remote likelihood that a misstatement of the District's financial statements that is more than inconsequential will not be prevented or detected by the District's internal control.

A material weakness is a significant deficiency, or combination of significant deficiencies, that results in more than a remote likelihood that a material misstatement of the financial statements will not be prevented or detected by the District's internal control.

Our consideration of the internal control over financial reporting was for the limited purpose described in the first paragraph of this section and would not necessarily identify all deficiencies in the internal control that might be significant deficiencies or material weaknesses. We did not identify any deficiencies in internal control over financial reporting that we consider to be material weaknesses, as defined above.

Compliance

As part of obtaining reasonable assurance about whether the District's financial statements are free of material misstatement, we performed tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a direct and material effect on the determination of financial statement amounts. However, providing an opinion on compliance with those provisions was not an objective of our audit and, accordingly, we do not express such an opinion. The results of our tests disclosed no instances of noncompliance or other matters that are required to be reported under *Government Auditing Standards*.

This report is intended solely for the information and use of management, the board, and federal awarding agencies and pass-through entities and is not intended to be and should not be used by anyone other than these specified parties.

Other Minutes

Water District 110 Advisory Meeting
2/06/2008

Kirk Jacobs called the meeting to order at 10:12 am. Those in attendance were Kirk Jacobs, Don Parker, Lyle Swank, Mike Cope, Blake Jordan, Darren Bitter, Wendy Murphy, Gene Hansen and Lisa Purvis.

Lisa Purvis read the minutes. Lyle Swank changed the word negotiated to facilitated in the first sentence in the 5th paragraph. Don Parker motioned that the minutes be accepted as read with the correction and Darren Bitter seconded and the motion carried.

Discussion moved toward the Notice of Violations. Violators are Chris Larsen, Elmer Carpenter, Lewis Newman, Lloyd Barzee, Frank Sullivan, Blaine Larsen and Neal Sauer. Don Parker felt that Elmer(Ed) Carpenter should not have been fined \$1700 as he was new to the property he inherited from his father. He feels that a warning should have first been sent to new owners. Lyle said it is rough process to get people in compliance but, in the long run it is in the best interest of the department. Gene suggested that it can become a department liability if water rights are not enforced. When a buyer purchases property, it is their responsibility to check water rights.

Wendy then gave the financial report in draft form as they are currently being audited. Water District 110 income was \$58,397, total expenses were \$53,622. Net income is \$4,775. The checking account has \$29,090 and total liabilities and equity of the district is \$28,197.21. Don Parker moved to accept the financial report, Darren seconded and the motion was carried. It was indicated that the Watermaster services are covered by IDWR until 1/31/2008.

Lyle and Blake Jordan gave the watermaster report. Lyle said that the water supply is looking better but we need more snow pack. Palisades/Jackson is at 25% capacity. We still need more snow and rain. Winter releases are 800 cfs out of Palisades. Lower releases help fill reservoirs. The result is a better chance to keep water in the Basin. Gene said there is 44% of water in system.

Blake Jordan presented the 2007 accomplishments which included measuring 260 wells, slightly more than 1/3 of the 746 wells in WD 110. He presented a measurement breakdown of pumpcard returns, water usage on randomly selected water rights; well depth and water level trend charts. Blake indicated the Water Management Information Systems (WMIS) is used to store water consumption information. This system is updated on a continual basis. If you have any questions about your water use, please call Blake. We can usually answer any of your water consumption questions using WMIS. His goals for 2008 include revisiting and re-measuring diversions with questionable data, diversions measured in 2005, and diversions missed in 2007. Don moved to accept the watermaster report, Darren seconded, and the motion was carried.

Lyle recommended a correction in the 2008 resolution #2 for Gene Hansen to replace Lyle Swank as watermaster. Watermaster services were approximately 160 hours work.

Don Parker discussed whether they should take a proposal from another contractor. Kirk said that he felt safer with IDWR. Don wanted Wendy to send a breakdown of secretary, hydrographer, and watermaster costs through E-mail.

Don Parker wanted a list of violators and to be notified in the future before fines are issued. Gene said that they do not get records until end of year because it is from the power companies. Kirk and Don proposed notifying last year's violators so they would not be in violation again this year.

Don motioned to adjourn the meeting, Darren seconded and the motion was carried. The meeting adjourned at 12:50 pm.
