Re: Water Measurement Plan Submittal

Dear Water User,

The Idaho Department of Water Resources ("IDWR") issued a Final Order Requiring Measuring Devices for Ground Water Diversions in Water District 140 on June 29, 2009. This Final Order requires that flow meters be installed on irrigation wells by the start of the 2011 irrigation season (required on all wells used for irrigation of more than five acres). The Final Order further required well owners to submit measurement plans to IDWR by May 15, 2010.

The purpose of this letter is to remind you of the 2011 irrigation flow meter installation requirement and deadline, and provide you notice that IDWR has not received any measurement plan(s) for your irrigation well(s). IDWR requests your cooperation in completing a measurement plan for each irrigation well that you own using the attached measurement plan form (one form per well). Completed forms must be returned to IDWR by November 30, 2010. IDWR will review the plans and provide approval or other response as soon as possible. Measuring devices for closed conduit systems or pipes must be magnetic flow meters meeting IDWR criteria unless a variance has been approved by IDWR. The Final Order provides that IDWR may consider alternative measurement methods and flow meters upon submittal of the above referenced measurement plan form by the well owner or operator. Please refer to IDWR's "*Minimum Acceptable Standards for Open Channel and Closed Conduit Measuring Devices*" for information on acceptable types of measuring devices. IDWR and the Water District 140 watermaster will inspect irrigation wells next season for compliance with the Final Order. IDWR may issue a Notice of Violation if acceptable flow meters are not installed in accordance with the Final Order. Please note that issuance of a Notice of Violation can result in monetary civil penalties pursuant to Section 42-1701B, Idaho Code.

Please note that the Department will be hosting a magnetic flow meter workshop on November 16, 2010 at the Best Western Convention Center in Burley. A workshop notice and agenda will be mailed to you over the next few weeks. IDWR encourages you to attend this workshop to learn about IDWR's measurement requirements and obtain information about types, costs, and installation of magnetic flow meters.
