MINUTES OF 2009 MEETING

FINANCIAL REPORT

A copy of the Profit & Loss vs. Actual was distributed. Kim Thomas made a motion to accept the financials as presented. Kerry Cheney seconded. All "aye". Motion carried.

OLD BUSINESS

Discussion included Water Master Sager on the weirs and RJ Smith on High Flow Claims. No agreement with reconnects has been established.

NEW BUSINESS

Budget-Chairman Ellsworth presented to 2010-2011 proposed budget. The projected income to cover the apportioned budget minus \$4000.00 of the bank balance carry over is \$57.40 per cfs, up from last year by 4.40 cfs.
