Please be advised of the 2010 irrigation season delivery call for the following surface water rights in their respective priorities and quantities pursuant to Water District 34 Distribution Rule 40 and the SRBA partial decrees.

This call is for the delivery of the above listed water rights and the curtailment of all junior diversions from administratively connected water supplies of the Big Lost River and tributaries. This call also applies to all prior water rights which may exist where no actual delivery call has been made pursuant to Rule 40.05 and in compliance with Water District 34 Guidelines of Operation procedure 3.5 Record Keeping. Initial preferred use will be delivery to owner's field headgate or, in the alternative I will notify the ditch rider of co-mingled rotation in the common canal with other water users as per our arrangement.


A separate notice of delivery will be made at a later date regarding the call and release of storage allocations of water impounded in the Mackay Reservoir, pursuant to the nine (9) water rights held by BLRID, which the above named water users are entitled to. BLRID management is not authorized to release from storage and/or deliver any such storage allocations until a specific call for such is made in writing. Please forward the 2010 storage allocation notice ASAP.

I will also notify the appropriate ditch rider(s) prior to the introduction of certain groundwater diversions into the Eastside-Island-Munsey conveyance system operated by BLRID as per the terms of the 2010 transport agreement. Also, please be advised Ronald Sorensen will be acting as my water lateral manager again this year.

Please notify your respective deputies and ditch rider(s) of this delivery call. Also, please note enclosed payment of 2010 Water District fees and BLRID O&M assessments.
