NOTICE OF HEARING

On June 12, 2013, the Director of the Idaho Department of Water Resources (IDWR or Director) received correspondence from Rob Harris of Holden, Kidwell, Hahn & Crapo P.L.L.C. written on behalf of Jay and DeAnn Jensen. The letter is a formal request pursuant to Section 42-605(9), Idaho Code for the removal of the current watermaster, Roger Totten. Section 42-605(9), Idaho Code reads as follows:

The director of the department of water resources may remove any watermaster whenever such watermaster fails to perform the watermaster's duty, upon complaint in that respect being made to the director in writing, by one (1) person owning or having the right to the use of a water right in such district, which right has been adjudicated or decreed by the court or is represented by valid permit or license issued by the department of water resources provided, that upon investigation the director, after a hearing with the other water users of said district, which shall be held in the district or at some location convenient to the water users of the district, finds such charge to be true, and the director may appoint a successor for the unexpired term.

PLEASE TAKE NOTICE that a formal hearing will be held on **July 9, 2013 beginning at 9:00 a.m. in Arco, Idaho** at the Business Incubation Center, 159 N. Idaho, Suite 203, Arco, ID. The purpose of the hearing is to gather testimony from the petitioners, the watermaster, and others to determine whether the Director should remove the current watermaster pursuant to Section 42-605(9), Idaho Code.

If you plan to offer exhibits for the record at the hearing, note that Rule 606 of the Department's Rules of Procedure requires that a copy be provided to each party and to the presiding officer.

The presiding officer at the hearing will be IDWR Director Gary Spackman.

The hearing will be held in accordance with the provisions of Chapter 17, Title 42 and Chapter 52, Title 67, Idaho Code, and the adopted Rules of Procedure of the Department, IDAPA 37.01.01. A copy of the rules may be obtained from the department upon request or from the following website: <http://adminrules.idaho.gov/rules/current/37/0101.pdf>.

The hearing will be conducted in accordance with the accessibility requirements of the Americans with Disabilities Act. 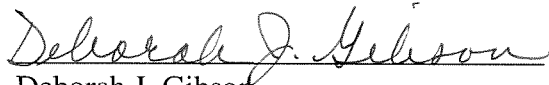
