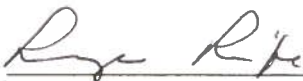
- ❖ Financial statement read by Randy Capps. Current statement reports 2600.00. It was decided this year dues zero.

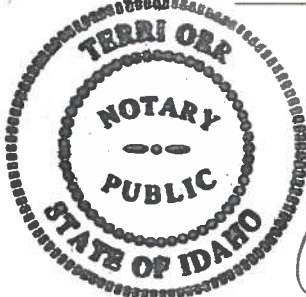
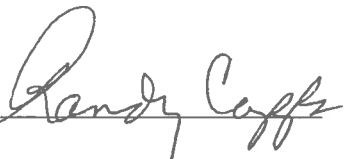

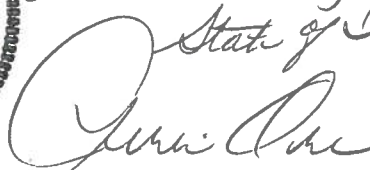
