RE: 2014 Alternative Mitigation Plan Pursuant to IDAPA 37.03.12.050.e

The undersigned **Group of Individual Water Users (GIWU)** holding valid groundwater rights within Basin 34 submit the following mitigation plan to the Director of the Idaho Department of Water Resources pursuant to IDAPA 37.03.12.050 (Rule 50) in response to a mitigation request made by several surface water holders referenced in a letter dated May 16, 2014 from IDWR. This plan is intended to be implemented by GIWU so as to avoid the curtailment of their respective ground water diversions. This alternative mitigation plan is authorized by the Water Distribution Rules – Water District 34 and is framed within the discretionary provisions contained within Rule 50.

RELEVANT COMMUNICATIONS AND SUPPORTING DOCUMENTS

- 1.) **IDWR letter** dated September 19, 2013 from Director Gary Spackman to Mike Telford. This letter contains a series of questions and answers regarding mitigation plans and institutional structure. Question 6 of that letter states: “Can the new district or an individual, depending on answer to questions above, propose a plan for their proportionate share of the mitigation burden under Rule 50?” Answer: “Yes”
- 2.) **Attachment I:** 2013 Well Data EOY LRE. The accuracy of this WD34 document is questionable, but it is the only report available showing the amount of water individual ground water users diverted in 2013. It will therefore be used in this plan to establish the proportional amount of mitigation burden under Rule 50 each of the GIWU individuals is responsible for.
- 3.) **Attachment II:** Big Lost River Irrigation District storage water allocation cards showing the amount of storage water each GIWU individual is entitled to receive. The Board of Directors of the BLRID has allocated specific water supplies impounded in the Mackay Reservoir to the patrons of the district. Patrons are entitled to these allocation supplies and may call for various releases and deliveries as per their discretion and district policies.

4.) **Attachment III:** A detailed description of natural flow right(s) which will be rotated into credit and then used for mitigation purposes. The original irrigable place of use acres for these WR(s) will not be irrigated this season. Relevant lease/rental agreements relating to these WR(s) are included in the attachment and Drought Emergency Transfers, if needed, for such WR(s) are pending.

5.) **OFFER LETTER(s) TO LEASE/RENT GROUNDWATER RIGHT(s).** These offer letters have been sent to the respective right holders. It is not likely the proposed business transaction will be completed by the due date of this mitigation plan submittal (June 2, 2014). However, GIWU will continue to pursue those offers and will provide updates to IDWR regarding the temporary use of those ground water rights as contemplated in the May 16, 2014 IDWR letter and the offer letter(s).

PROVISIONS AND CONDITIONS

1.) The total amount of water provided by GIWU for mitigation for the 2014 irrigation season will be 654.23 acre-feet. (See Table 1.) This supply will be provided from storage allocations and rotation credits, as provided for pursuant to Rule 40, and are vested water supplies held by GIWU individuals. (See Attachments II and III)

2.) This supply of mitigation water will be used exclusively for the general augmentation of the natural river flow and not the direct augmentation of the water rights held by those surface users calling for mitigation. Those surface right holders may receive a portion of the general river augmentation supply as the watermaster determines the available supply of the combined natural flow (current natural flow and augmentation supplies) and the priorities that can be delivered based upon the mitigation call as described in the May 16, 2014 letter from IDWR. This approach means augmentation will continue even when the callers for mitigation water right priorities are being satisfied with the combined natural flow, and will only cease when either: a.) all surface water rights with 1905 and earlier dates are satisfied as described in Rule 050.04.b., or b.) when the surface water of the river becomes futile as described in Rule 020.04.

3.) Due to the irrigation season having already commenced, the augmenting supply of one third (1/3 of 654.23) 217.85 acre-feet will be released/diverted by WD34 watermaster into the river channel or canal laterals in equal amounts for the remaining days of the first semester. The remaining two thirds (2/3 of 654.23) 436.48 acre-feet will be released/diverted into the river channel or canal laterals in equal amounts for the 84 days of the second semester, subject to condition No. 2 described above.

4.) This proposed mitigation plan is intended to be upgradable, expandable, and duplicable if approved. Due to the shortness of time, GIWU was not able to contact other groundwater users. This proposed plan primarily focuses on the use of storage and natural flow supplies and does not explore other remedies that may have merit. Other groundwater users may join this plan subsequent to its approval by adding mitigating water supplies and descriptive details. It is expected if IDWR does not approve this plan, IDWR administrators will explain any deficiencies in detail and allow the participating individuals opportunity to amend and modify this plan.



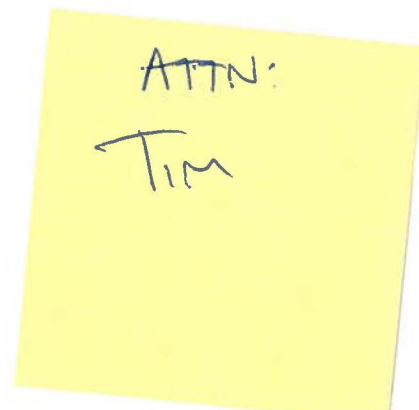
