WATER DISTRICT NO. 65-K Minutes, Annual Meeting March 1, 2010

The annual meeting of Water District No. 65-K was held on March 1, 2010 at 1:00p.m.at the fire station in Donnelly, Idaho.

The following were present: Rob Whitney(IDWR), Art Troutner, Harry Bettis, John Leedom, Ron Nahas, Jonn Hickok, and Shirley Florence.

The meeting was called to order by Art Troutner. Art Troutner made a motion to appoint Harry Bettis to act as chairman for the meeting. Ron seconded the motion. Motion carried. Shirley Florence was reappointed as Secretary for the year.

The following business was transacted:

1. The minutes of the March 3, 2009 meeting were read. Art made a motion to approve the minutes. It was 2^{nd} and the motion passed.

2. The financial report was presented. \$4006.01 on hand (report attached). The county overlooked sending the remainder of the revenue collect from last year. Shirley spoke with them today, and they are putting a check in the mail

3. The watermaster's proposed budget for the year 2010 was presented. The amount proposed is \$5206.00. Ron made a motion to approve the budget as presented. It was seconded and the motion carried.

4. Art moved to keep the water master's wage at \$43.00 a day. It was seconded and the motion carried.

5. Shirley read the following resolution pertaining to the collection of water user fees as set by the budget:

• "The water users of Water District No. 65-K do hereby resolve: that no ditch or canal company, or other water user shall have the right to demand and receive water, and the water master shall not deliver to such water user, until the amount due and payable from such user, as set forth by the budget, has been paid."

Art motioned to accept to resolution. It was seconded and the motion passed.

6. Harry nominated John Leedom as watermaster for the coming year. The motion was 2^{nd} . John was elected by unanimous vote.

7. Chariman Bettis appointed the following to the advisory committee: Justin Florence, Jake Maki, and Harry Bettis. 8. Report for the 65-K rental Pool: 256.03 acre feet of water was rented out. (report attached) There is an accumulated balance of \$2202.04 in the rental pool account.

9. Other Business:

1. John mentioned that there is a weir on the Cruzen ditch that needs fixed.

2. Rob Whitney from the Idaho Department of Water Resources informed the board that the regional manager has suggested that smaller districts might want to consider combining their districts. There was general discussion from the attending members. The consensus was that no one felt it was worthwhile at this time.

10. With no further business, Art motioned to adjourn the meeting. It was seconded and the motion carried. The meeting adjourned at 1:50p.m.
