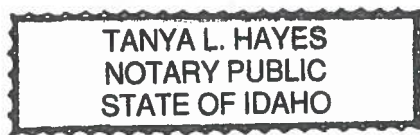

Chairman Don Ellis started by acknowledging Chet Park's many years of dedicated service to the water district.

Don called the meeting to order at 7:02 pm. Seventeen people were present. Don explained that the purpose of this special meeting was to elect a watermaster to replace Chet Park, recently deceased. No other business could be addressed because it was a special meeting, advertised for that specific purpose only.

The methods of voting we explained. The usual manner is one vote per water right holder present. The alternate method is that each water right holder present has the same number of votes as water rights. (ie. A person present with 5 water rights would have 5 votes). As no one requested the alternate method of voting, the usual method of voting was used.

Don opened the floor for nominations for watermaster. Dean Primmer nominated Laurin Scarcello. The nomination was seconded by Dan Park. As there were no more nominations, the nominations were closed.

The chair entertained a motion for a unanimous ballot to be cast. Dan Park so moved. Dean Primmer seconded the motion. The group then cast a unanimous ballot for Laurin Scarcello.

The chair entertained a motion for adjournment. Dean Primmer so moved. Dan Park seconded the motion. The group voted to adjourn the meeting.

The meeting was adjourned at 7:08 pm.
