RESOLUTIONS PERTAINING TO THE TIME AND MANNER OF COLLECTING THE BUDGET AS ADOPTED AT THE ANNUAL MEETING OF THE WATER USERS OF WATER DISTRICT NO. 45A

Eugene Matthews, Chairman of the Board, called the meeting to order at 7:01 P.M., on January 11, 2018. The meeting was held at the Oakley Fire Station located at 100 East Main, Oakley, Idaho. Eugene Matthews, Jared Bedke, Danielle Bedke Helms, Seth Larsen, Linda Zollinger, Craig Smith, Gerald Marchant, Ryan Hawker, Nathan Erickson (DWR-Twin Falls), and Vickie Smith were in attendance.

BUSINESS____

MINUTES

The minutes from the January 11, 2017, meeting were read by Vickie Smith. The minutes were reviewed and discussed by those in attendance. A copy of the minutes and the bank statements from the 2017 year were available for attendees to review before the reading of the minutes.

FINANCES:

The financial statement was reviewed. We have \$10,292.29 in the 45A account at the D. L. Evans Bank as of December 1, 2017. All transactions for the Water Year have been paid and accounted for. Danielle B. Helms's end-of-the-year report payment (\$500) was paid to her at the meeting. It will be deducted from the retained funds on the January, 2018 bank statement.

ELECTION of a CHAIRMAN and WATER BOARD MEMBERS for 2018:

Eugene Matthews was nominated for Chairman of the Board . He accepted the position . Everyone was glad that Eugene was willing to be the Board Chairman again. He is very knowlegable about the water issues in the Basin. A vote was taken to accept Eugene as the Chairman, the outcome was unanimous.

Eugene then appointed a <u>Water Board</u> to work with him. The Board members will represent the following streams:

MILL CREEK: Jared Bedke/Craig Hawker

SPRING CREEK: Craig Smith
SUMMIT CREEK: Seth Larson

SECRETARY/TREASURER: Vickie Smith (salary) \$250.00

Nathan Erickson asked about our insurance situation. We pay a yearly fee to the State Insurance

Fund, but we don't own equipment, so we don'thave any items to insure.

WATER MASTER REPORT and UPDATE of CONCERNS:

Danielle B. Helms gve her report about the water year 2017. It was a good water year. Some concerns that were discussed were the following:

- *Hawker's renting Neil Justesen's water. Water right has a speific diversion-water right needs transferred legally at the point of diversion. Nathan Erickson said to contact the DWR. Ryan Hawker said that he would.
- *cleaning out the willow's north of Craig Smith's in the ditch/creek. Nathan suggested calling the person at DWR who knows about stream channels.
- *spraying for thistle at the Summit Creek feeder and the crossing at Spring Creek; follow labeled instructions; who is responsible for what—the property owners or the Water District? Casey Bench could be the person who could apply the spray. Several people said that they would check about this. *Bobby Critchfield's desire to divert water for Mill Creek at his new house for landscaping purposes. Not acceptable. Eugene will discuss this with Bobby.

ELECTION of a WATER MASTER for 2018:

Eugene asked Danielle if she was interested. She was, but she would like a raise from \$5,000 to ??? She needs the money to help alleviate the rising prices associated with her job. Everyone felt like a raise was a good idea. The total amount was decided to be \$5,200 for Water Year 2018. Dividing \$5,200 by the month and with the \$500 end-of-the-year report it will be as follows: \$5,200 - \$500 (year-end report) = \$4,700; \$4,700/6 = \$783.34 per check (April-September) \$33.34 more than 2017 per month. Danielle said that that was acceptable and she thanked the attendees. Danielle has done a great job as the Water Master!

MOTION to accept Danielle as the Water Master: Linda Zollinger

MOTION seconded: Jared Bedke

THE ASSESSMENT/BUDGET:

Discussion about whether to keep the water assessment at \$4.00 (2017) per share or change it. In 2015-2016, the water assessment was \$8.00 per share Looking at our financial state, the group decided to raise the assessment to \$5.00 per share in case we have some repairs that we need to hire operators and equipment for. That was reasonable and acceptable to the water users in attendance.
