ORDER VACATING CONTINUED PREHEARING CONFERENCE AND DISMISSING CONTESTED CASE

### **BACKGROUND**

On October 13, 2017, the Upper Big Lost River Ground Water Association ("UBLRGWA") filed with the Idaho Department of Water Resources ("Department") a Mitigation and Aquifer Enhancement Plan of and for the Upper Big Lost River Ground Water Association Users ("Mitigation Plan") pursuant to Rule 50.04 of the Department's Water Distribution Rules for Water District 34 (IDAPA 37.03.12.050.04) and the Department's Rules for Conjunctive Management of Surface and Ground Water Resources (IDAPA 37.01.11).

The Department published notice of the Mitigation Plan in the Arco Advertiser, Challis Messenger, and Post Register on November 16<sup>th</sup> and 23<sup>rd</sup>, 2017.

Big Lost River Ground Water District; Idaho Ground Water Appropriator's, Inc.; Big Lost River Irrigation District; and Joel S. Andersen filed protests to the Mitigation Plan. The Director of the Department ("Director") considered this matter a contested case pursuant to the Department's Rules of Procedure (IDAPA 37.01.01) and notified the parties of a prehearing conference.

On March 13, 2018, Harvey Walker filed a Petition to Intervene which the Director granted on March 27, 2018.

The Director held a prehearing conference on March 29, 2018. All parties were present at the prehearing conference. The parties agreed to schedule a continued prehearing conference on April 25, 2018.

On April 19, 2018, the Director received a letter from the UBLRGWA withdrawing the Mitigation Plan. Accordingly, the Director will vacate the continued prehearing conference and dismiss the contested case.
