Craig Crandall said that this board recommended Steve Hebdon to be hired as Water Master for 2018 irrigation season for \$16,0000.00 wages, and \$10,000.00 expense with Kevin Hebdon as an assistant at no additional expense to the Water District, Cory Fly made the motion to accept the board recommendation to hire Steve Hebdon as water master, Kevin Hebdon as assistant at no additional expense to the water district, Brett Casperson second, motion passed. Craig Crandall stated that the board

Bryan Allen seconded it, motion passed. Meeting Adjourned at 2:22 P.M.

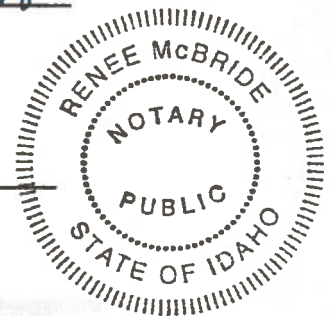

There was no Motion to Adjourn. Board left at 1:30 P.M.

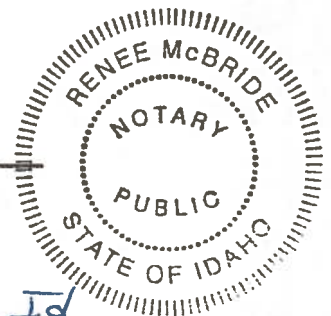
