Dear Director Spackman:

It is my understanding that the Water Department had a meeting last week of interested water users to determine whether to include the Camas Creek drainage area in Camas County in a new district with the Wood River valley users. This is proposed, ostensibly, to clear up priority issues that concern the Wood River canal company's rights in Magic Reservoir. I am writing you this letter in response to your call for a 10 day comment period.

I am a lifelong resident of Camas County who has always lived on and had water rights on Corral Creek and Camas Creek. I hold the degrees of Bachelor of Science of Geological Engineering, Bachelor of Science of Metallurgical Engineering and Master of Science of Metallurgical Engineering from the University of Idaho. I have been a licensed well driller in Idaho since 1967. My company designed and drilled the majority of the irrigation wells that are now being pumped in this valley and drilled the primary well for the Village of Fairfield. I have test pumped the wells that I drilled in a structured and scientific manner using the method developed by the staff of the Johnson Well Screen Company. The Johnson test was developed from the Modified Theis formula. I was retained for many years to collect well performance data during the pumping season for the Camas Creek Ranch who owns a widely spaced array of irrigation wells all over this valley. I am absolutely positive that I have the only valid long term data of the performance of the aquifer that underlies the Camas Prairie.

As a user of water rights that are far superior to anything that the Wood River Canal Company has and as a pioneer in the development of and cognizant of virtually every deep well used for irrigation in this valley, I feel that the knowledge and data that I have of the water use and of the water potential of this valley is equal to or superior to any official water survey or any person living.

It is demonstrable both by observation and history that the possible effect on the water flows in the Wood River drainage due to pumping in this valley is disappearingly minimal. The data that I have collected shows that this valley is a standalone water system and that it has not been fully developed to the benefit of the residents of this valley. Historically, Camas Creek floods with the snow melt in the spring for 6 to 8 weeks and then, because of surface water rights on its tributary creeks that were granted in the early 1880's, virtually dries up. The traditional outflow of Camas Creek has historically been sufficient to provide 40 to 60% of the storage capacity of Magic Reservoir. 50 or 60 years ago the Wood River flow filled the reservoir and flowed enough to keep it full well into midsummer. For those of us who have lived here that long, the problem for the canal company comes from the continuing greening of the Wood River valley. When I was a young man, driving up highway 75 (then Highway 93) from Timmerman Hill to North Fork, there were large areas of un-watered ground south of Bellevue, between Bellevue and Hailey, between Hailey and Ketchum and between Ketchum and North Fork. Now it is virtually all lawn, grass, forest, landscaping or pools. Since the irrigation rights in the Wood River valley were already adjudicated before 1900 and what was left over was filed on by the Wood River Canal Company for Magic reservoir, the only possible way that all that greenery can be irrigated is from ground water. I would point out that the Idaho Constitution provides that domestic

water use from wells can be no more than 9 gallons per minute. As a farmer and irrigator for some 40 years, I would suggest that grass pastures and arboretums take a lot of water. As a well driller with about 45 years of experience in drilling and pump installation, I would point out that a well with a 50 foot lift does not require a 3 to 10 horsepower pump to provide the 9 gallons a minute allowed a domestic user ... $\frac{1}{2}$ to $\frac{3}{4}$ horsepower will generally do the trick. I would suggest that if the Wood River canal company is not receiving its legal share of water that they measure the discharge of the domestic wells in the Wood River valley.

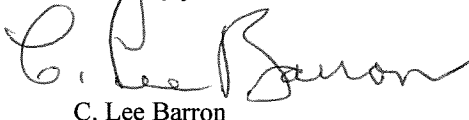
As to the Camas Creek drainage, it is apparent to me because of my study and observations that it has almost no effect on the lower Wood River valley after the snow melt has been drained. I know that over the years that the water department has held that it and its tributaries are intermittent streams and I have documentary evidence that this has been true for at least 90 years.

I would assert that the water department must model the Camas Creek drainage system and characterize the Camas Prairie aquifer before making any determination to include it in a water district with the Wood River valley. If that study should find that the Camas area does indeed stand alone, I would strongly recommend that the irrigation well moratorium on this valley be lifted so that the citizens of this county can enjoy the benefit of their resource.

I would also point out that if the Camas drainage is included with the Wood River valley drainage to be managed as a single unit, then it would be possible for the water from the Camas drainage to be transferred up the Wood River valley. I believe that the great difference in population between the two areas would soon work a tyranny on the residents of Camas County. I also believe that this would be a violation of a long standing principle in Idaho water law to deny transfer of water from one drainage to another.

I would ask you to declare the Camas Creek area a separate water district and I stand ready to support my assertions in support of this determination with testimony and data at your desire.

These are the comments of the City of Ketchum in response to the Director's proposal to take action to consolidate and/or eliminate certain administrative bodies in Basin 37 as outlined in the Notice of Public Hearing issued on July 10, 2013 ("Notice").

Although four potential actions are proposed in the Notice, the City of Ketchum is focused on proposals (c) and (d) which are identified as:

- (c) Include in the combined district ground water rights from the Upper Wood Rivers Water Measurement District (UWRWMD) overlying the combined district and located in that portion of the Department's Administrative Basin 37 outside of the Eastern Snake Plain Aquifer (ESPA) and WD130 as shown on the map in Attachment A of this notice; and
- (d) Abolish the UWRWMD.

COMMENTS OF THE CITY OF KETCHUM - P. 1

At this time, with reference to item (c), the City of Ketchum opposes inclusion of ground water rights from the Upper Wood River Water Measurement District (UWRWMD) into Water District 37.

With response to item (d), the City of Ketchum recommends not abolishing the UWRWMD.

The only basis provided by the Notice for items (c) and (d) is that "The combination and revision of water districts as proposed in this hearing notice is necessary in order to properly administer the water uses and water rights from both surface water and ground water sources in the combined water district area." See Notice, p. 2. The City of Ketchum does not believe this conclusory statement is adequate to support consolidation of ground water sources and surface water sources into a single district given the nature of measures underway in Basin 37. Further, there are various aspects to a combined water district that are completely overlooked in the Notice.

The Department, in cooperation with USGS, is currently undertaking to develop a ground water model that most informed users recognize will play a role in implementing conjunctive management in Basin 37. Until that model is completed, combining ground water and surface water into a single district is premature. There are too many hydrologic unknowns between ground and surface water resources to support such a significant step.

Operation and functioning of a water district reflects hydrologic, economic, and administrative components. No information is provided in the Notice as to how these various

functions would be handled in a combined ground/surface water district. Any Notice regarding a combined district should, at a minimum, explain costs, management, potential administrative conflicts between ground and surface users and identify hydrologic issues such that forming such a district is prudent and informs potentially affected members. The Notice does not meet that threshold. A new, combined district should not lead to more complications than it eliminates. The current Water District 37 water master is doing a good job. How and whether he would be able to handle a combined ground/surface water district needs to be considered and explained. If existing Water District 37 assessments would increase, current members need to be made aware of that. The same is true for members of the UWRWMD. Thus, a budget for a combined district should be presented as part of any proposal to significantly modify existing Water District 37 operations.

Importantly, if conjunctive management issues create a need for certain water users to mitigate for potential impacts, it would be difficult to have too broad a membership reflected in a single district. Some surface water users have generically suggested ground water users will be required to mitigate for impacts to surface water rights. That is not an immediate issue, but it would be extremely difficult, and perhaps legally impossible, to address such allegations in a combined district.

The UWRWMD has made considerable progress with its duties and has apparently done so in an efficient manner at a reasonable cost. It appears to be working as intended. The City sees no reason for changing what is working.

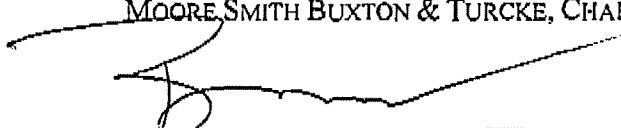
Given the lack of detail and explanation supporting a combined ground/surface water district, coupled with potential conflicts, the City cannot support combining ground water rights with existing Water District 37 at this time. The record does not support such a decision.

CONCLUSION

Ground water rights should not be included in Water District 37. The UWRMD should remain in place.

I am writing to give testimony concerning the combination of water districts in Basin 37 and the inclusion of ground water and surface water into a combined water district in Basin 37.

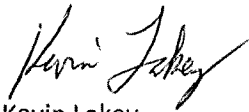
During testimony on July 30th in Hailey, some witnesses voiced concern that a water district with both surface and ground water would leave ground water users with no voting power if a credentials/assessment vote were taken because surface water users divert so much more water than ground water users. Their testimony also implied this voting power could then be abused when conjunctive management was enforced in a combined water district.

As you and I both know, water users will not vote on how conjunctive management will be enforced. Water users only vote on budget, hiring, and resolutions. IDWR will enforce conjunctive management. Also, as to representation on an Advisory Committee, the representation of our current committee is not based on volumes of water diverted. It is based loosely on geographic region and types of beneficial

use. If/when a new water district is formed; a steering committee will be selected to decide how the advisory committee will be organized. From past experience with water users in this district, I am confident a fair representation of all water users will be established. I fully appreciate the fact that ground water users are apprehensive about moving into a water district and ultimately face regulation, but I believe their worries about equal representation are unfounded.

Thank you for the opportunity to submit this testimony, and I look forward to your order being issued later this year.

Thank you for the opportunity to review and comment on the proposed water district combinations and abolishment of the measurement district as noted above.

As you may know, Idaho Department of Lands' (IDL) mission is to manage State Endowment Trust Lands (Endowment Lands) in a manner that will maximize long-term financial returns to the Beneficiary Institutions. The IDL mission is a constitutional mandate and is overseen by the State Board of Land Commissioners. Endowment Lands are not managed for the public at large and should not be referred to as "public lands" or "open space," either specifically or in a generic sense. These are working lands producing revenue for the Beneficiary Institutions.

IDL has reviewed the public hearing notice provided by the Idaho Department of Water Resources for the applications as listed above. Based on the documentation provided to IDL, the applications will not impact Endowment Lands at this time. Should the applications be modified during the review or approval process, IDL requests that updated information be submitted to IDL's Eastern Supervisory Office for additional review.

I attended and testified at the hearing on July 30. After hearing some of the testimony I felt more comment was needed.

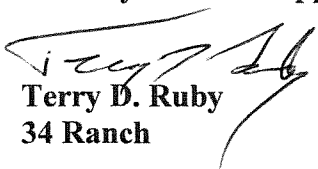
My family has owned property in Hill City since 1901 with the filing on our spring around 1903. This spring irrigates approximately 220 acres and is used for stock water as well.

In the late 70's a well was illegally drilled approximately 1 mile east of our spring and through the early 80's it continued to drain our spring, most times as quickly as 24 hours after turning on. This well was found to have been drilled with slotted pipe to take advantage of the surface water. This well collapsed in the early 80's and the owner requested to re-drill. IDWR, the owners and ourselves met in Fairfield to discuss this matter and the well was drilled with the stipulation that it be solid cased below the surface water depth so as not to affect our spring. To date, this well has operated with no noticeable effect on our spring.

I don't know if there are other wells in the area that have been drilled to take advantage of the surface water but I would like to see IDWR look at those drill logs to find out.

I further feel that Camas County should be one measurement district and not combined with the rest. It is a different water shed than the Wood River Valley, it is less populated than the Wood River Valley and I fear that combining would bring about a voting war that Camas County would ultimately lose.

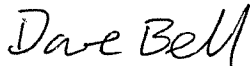

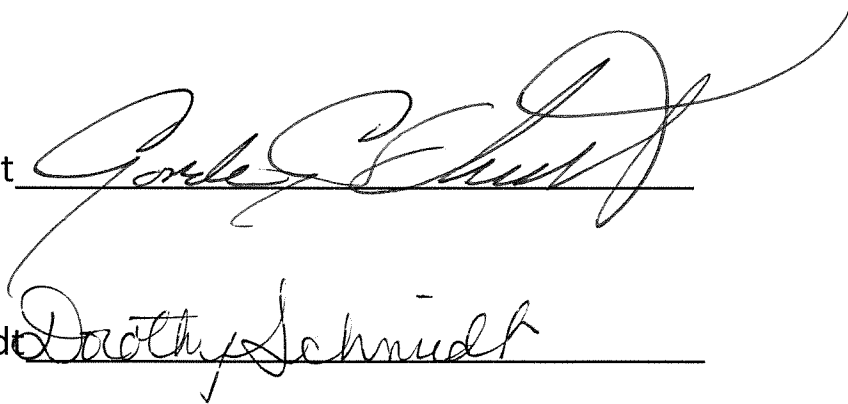

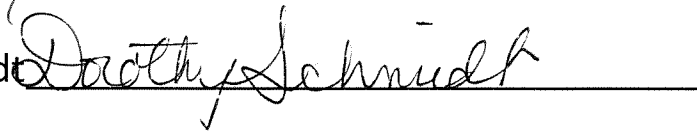

Dear Director Spackman:

I represent the owners of several surface and ground water rights and also hold small surface water rights personally. The purpose of this letter is to register my objection to the combination of the water districts as proposed in the above-referenced matter.

When the Upper Wood River Measurement District was initially proposed, its purpose was stated to be the predecessor to a Ground Water District. The present proposal sidesteps that step and creates a combined Water District for surface and ground water users. Given the potentially disparate interests of ground water users and surface water users, the present proposal undermines the ability of each to protect their unique rights. Until a workable plan for conjunctive management is agreed upon, including an accepted water model and appropriate methods for determining material injury and the cause thereof, it is inappropriate to have ground and surface water districts jointly administered.

In addition, the proposed inclusion of Camas County waters rights in the District makes little sense as mitigation efforts in Camas County would be wholly separate from those of the Wood River Valley and any administrative efficiency would be lost in addressing unrelated issues between the two distinct areas.

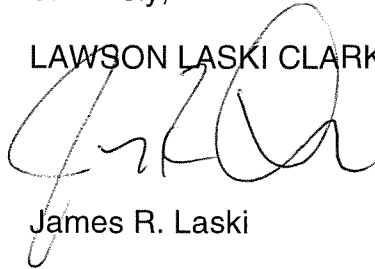

Dear Director Spackman:

I represent the Sun Valley Water and Sewer District, whose potable water supply is derived from various groundwater rights which it holds. My client has been an active member of the Upper Wood Rivers Water Measurement District with its general manager, Mr. Pat McMahon, serving on the District's Board. While my client understands, and agrees with, the abolition of the Water Measurement District, it has several concerns and questions over the proposed consolidation of the existing Basin 37 Water Districts and the inclusion of groundwater rights therein. Prior to the public hearing held in this matter on July 30, 2013, I spoke with Michael Creamer about the testimony he was going to provide at the public hearing on behalf of the City of Hailey, and request that your record in these proceedings reflect that the Sun Valley Water and Sewer District concurs with Mr. Creamer's testimony. My client's primary concerns for the proposed consolidation of the Districts are the need for assurances that groundwater users will be provided adequate representation on the advisory committee for the consolidated district, and more information on how administrative costs for the new district will be equitably allocated between ground and surface right holders. Finally, in the face of conjunctive management of groundwater and surface water rights within Basin 37, the Sun Valley Water and Sewer District remains concerned that the inherent and inevitable conflicts

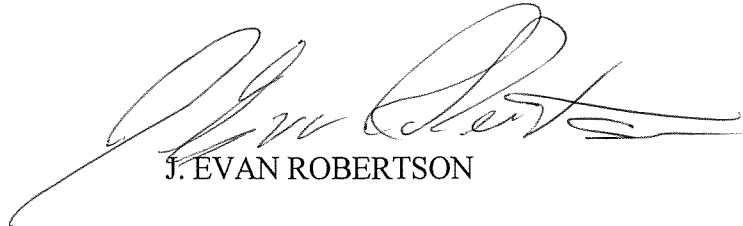

between groundwater uses and surface water uses will negatively impact the ability of the consolidated district to function efficiently and cooperatively. Givens Pursley represents the City of Hailey ("City") in the above-captioned matter. Please accept the following comments being submitted on its behalf pursuant to the Department's July 10, 2013 Notice of Public Hearing. These written comments summarize and supplement testimony presented on the City's behalf at the July 30, 2013 public hearing you recently conducted in Hailey.

As stated in the City's oral testimony, the City opposes the proposed action described in the Notice of Hearing that would include ground water rights from the Upper Wood River Water Measurement District ("UWRWMD") in Water District 37 ("WD 37") for purposes of administration. The City recognizes and appreciates the need for administration of decreed water rights, including ground water rights, within the Big Wood River Basin, but believes that this will be best accomplished by establishing a separate water district for ground water rights as was done repeatedly with decreed ground water rights within the Eastern Snake Plain Aquifer ("ESPA") area of common ground water supply. The reasons for the City's position are set out below.

1. Conjunctive Administration of Surface and Ground Water Rights Appears Imminent and is an Inherently Adversarial Process.

Despite somewhat equivocal statements made by Department staff and others in the past concerning whether conjunctive administration of surface and ground water rights will occur in the Big Wood River Basin, the City understands that conjunctive administration is imminent, and that administration of ground water rights can and will occur through water districts created pursuant to Title 42, Chapter 6, and as determined under the procedures established in the Department's Conjunctive Management Rules. IDAPA 37.03.11 ("CMRs"). The City understands that the surface water users in WD 37 have been intending this to occur as soon as the Big Wood ground water rights could be decreed and brought into a water district. The City also is aware of the recent correspondence between the Big Wood Canal Company and the Department specifically contemplating a delivery call under the CMRs.

The CMRs provide procedures for making a delivery call, and the factors by which material injury, the scope of any resulting administrative curtailments, and the sufficiency of proposed mitigation are determined. The process is inherently adversarial, at least initially. The experience with conjunctive administration in the ESPA bears this out. The City is concerned that the countervailing interests and concerns that come to the forefront in a delivery call proceeding cannot help but bleed over into the business of WD 37 if surface and ground water users are all consolidated into the same water district.

2. Ground Water Rights Will Have Inferior Voting Power in a Combined WD 37.

Aside from the high potential for distraction from the water district's business this consolidation will create, the City is convinced that that business will be decided and controlled solely by the holders of surface water rights. This is because under current statutes, surface water users will always have supermajority voting power on every matter that comes up for a vote if a request is made for voting based on the amount assessed for a water user's water right (i.e., based on the amount of water used). This includes election of the water master, approval of budgets, special expenditures and projects and adoption of resolutions. Idaho Code 42-605(4) provides that

Voting shall be by majority vote of the water users present at the meeting unless one (1) or more water users requests voting using the procedure which follows in this subsection. In such case the meeting chairman shall appoint a credentials committee to determine the number of votes each water user present is authorized to cast. If requested, each person present, owning or having the use for the ensuing season of any water right in the stream or water supply comprising such water district, which right has been adjudicated or decreed by the court or is represented by valid permit or license issued by the department of water resources, shall be entitled to

a number of votes equal to the average annual dollar amount and any fraction thereof assessed for that person's qualifying water right for the previous five (5) years, or such lesser number of years as the right has been assessed. If a right has not previously been assessed, a person present, owning or having the use of the right for the ensuing season shall be entitled to a number of votes equal to the dollar amount and any fraction thereof which the right would have been assessed had it existed and been reasonably used when water was available under the priority of the right during the previous season.

Based on the Department's estimates of the amount of water represented by surface water right holders in WD 37 and ground water right holders in the UWRWMD, potential surface water votes in the Department's proposed combined WD 37 would outnumber potential ground water votes by six to one.¹

Given the likelihood that implementing conjunctive administration in the Big Wood River Basin will be contentious, and that the move to conjunctive management will commence as soon as ground water rights are under a water district, the City believes it is ill-advised to place ground water rights in an existing water district where their interests will be essentially unrepresented.

3. It is Not Apparent that Costs of Water District Administration can be Fairly Allocated in a Combined WD 37.

As with the apparent disparity in voting power that surface water users and ground water users would have in a combined WD 37, the City is concerned that ground water users in a combined WD 37 would wind up bearing a disproportionate cost of water district operations.

For example, based on water district records maintained by the Department, the annual budget for WD 37 currently is approximately \$240,000 per year. By comparison the annual budget for WD 130, which includes primarily ground water users in the Magic Valley and North Snake Ground Water Districts has been approximately \$75,000 per year.² Those two Ground Water Districts within WD 130 provide for their own measurement, however, and so the WD 130 costs admittedly would be higher if the Water

² The North Snake Ground Water District represents approximately 840 wells, supplying water for DCMI uses and irrigation of approximately 100,000 acres. The Magic Valley Ground Water District represents approximately 500 wells serving DCMI and approximately irrigated 121,500 acres. The 2012 budget for WD 120, which also includes primarily ground water rights and 306 wells, was approximately \$114,000.

District had that responsibility. However, the UWRWMD's 2013 budget was \$71,500, and so it might be assumed that the annual cost of running a ground water-only water district in the Big Wood River Basin could be as high as \$145,000—still far less than the current WD 37 annual budget. The City believes allocating costs of a combined water district between surface and ground water rights will be problematic, and in light of the disparate voting power of water users in a combined district, there is substantial risk that the costs would not be allocated equitably.

4. Water Districts on the ESPA Provide Examples Where Separate Districts for Ground and Surface Water Rights Works Well.

As the Department knows, several large water districts composed primarily, if not exclusively, of ground water rights have been created and operational on the ESPA since 2002. These include WD 100 (St. Anthony-Rexburg), WD 120 (American Falls), and WD 130 (Thousand Springs). The water master in those districts is primarily responsible for measuring and recording water diversions, administering water rights in priority, curtailing unauthorized diversions and enforcing Department orders to curtail out-of-priority diversions determined to be causing injury to senior priority water rights not covered by a stipulated agreement or approved mitigation plan. Within these water districts, the primary responsibility of the organized ground water districts is to measure and report ground water diversions to the watermaster, and to develop and operate mitigation plans as approved by the Department.

The City believes that these ESPA water districts provide a good model for ground water administration in the Big Wood River Basin. The City requests that the Department convert the UWRWMD to a water district that includes those ground water rights currently within the UWRWMD's jurisdiction that were recommended and decreed in the SRBA for Basin 37, Part 3.³

The City recognizes that other models also exist on the ESPA (WD 110 and WD 140) in which ground and surface water rights have been included in the same water district, but the City also believes that unique facts including historical integration of ground and surface water use and administration distinguish these water districts. At the same time, the Department's use of "sub-districts" (such as is the case in WD 140) presents a potential middle ground approach that brings all water users in a hydrologic basin under the umbrella of a basin-wide water district but provides for administration in separate sub-

³ The City understands that some Basin 37 water rights were decreed, licensed or transferred with a condition substantially as follows: "Use of water under this right will be regulated by a water master with responsibility for the distribution of water among appropriators within a water district. At the time of this approval, this water right is within State Water District No. 37." The City does not read this condition as preventing a separate water district for such ground water rights. This condition contemplates that the water right might not ultimately be administered by the watermaster of WD 37, and could be included in a different water district when the time came for creating one if the Department so determines.

districts with separate governance, budgets, water masters and advisory committees. Each sub-district is represented on the advisory committee of the umbrella water district.

The City has limited understanding how the umbrella water district relates to the sub-districts in WD 140, but assuming that decisions within the umbrella water district cannot undercut the governance, operations and interests of water right holders in the sub-districts (i.e., the water district can be structured to avoid the potential of voting/cost allocation disparities of a combined district), then a sub-district approach might be acceptable.

The City appreciates the opportunity to submit these comments for the Department's consideration in this matter.
