Call Meeting to Order- VerNon Roche called the meeting to order at 2:00 p.m. and welcomed all in attendance (about 60 total).

Select Annual 2020 Meeting Chairman- VerNon Roche was nominated by Jake Johnson, seconded by Loy Pehrson. No other nominations were made. Motion passed unanimously.

Select Meeting Secretary- Hadley Clark was nominated by Joel Anderson, seconded by Jake Johnson. No other nominations were made. Motion passed unanimously.

Approval of 2019 Meeting Minutes- (see attached copy) Joel Anderson moved to approve minutes, Max Bingham seconded. Motion passed unanimously.

Snow Report- Water Master Lucas Yockey reported the current Sno Tel data is at 57% as of 02/28/2020

Recharge Report – Water master Lucas Yockey reported recharge

Water Master Report-

- Total recharge was 24,388 cfs
- Total surface water delivered was 76,123 cfs
- Total groundwater delivered was 28,872 cfs
- River flow at the 2B gage is 158 cfs as of 2/28/2020
- Mackay Dam is at 39,3000 AF and 90.87% full as of 2/28/2020
- River flow at the Arco gauge is "ice" as of 2/28/2020

Financial Report & Proposed Budget – Lucas reviewed the proposed budget line by line as shown on the attached handout. The Cost factor is 1.29 per cfs of usage in 2019. The 2019 cost factor is the result of "rolling back" \$49,056 from the 2019 budget into the proposed \$198,282 2019-2020 budget for an actual \$149,226 of new Water master tax.

Jake Johnson moved to approve the 2020-2021 budget as proposed, seconded by Herb Whitworth. Motion passed unanimously.

IDWR Water Right Accounting Review- David Hoekema gave the presentation (see attachment) regarding the water right accounting system for 2019 usage.
