MINUTES OF 2020 MEETING

FINANCIAL REPORT

A copy of the Profit & Loss vs. Actual was distributed. Stephen Shiner made a motion to accept the financials as presented. Ed Snook seconded. All "aye". Motion carried. Bank balance at April 1st is \$13,117.00.

OLD BUSINESS

Chairman Ellsworth stated that some progress is being made with the Lemhi Basin Settlement agreement to protect high water rights, protect fish habitat, and recharge.

Budget-Chairman Ellsworth presented to 2021-2022 proposed budget. Discussion included using 72.00 per cfs. Ed Snook made a motion to accept the budget as proposed. Lowell Cerise seconded. All "aye". Motion carried.

Directors-Ellsworth indicated that his, Director Fisher and Director Shiner's seats are up for election. Emil Herbst made a motion to retain Ellsworth, Fisher and Shiner. Ross Goddard seconded. All "aye". Both were elected and will serve a 3 year term.

Other Discussion- Assistant Water Master Josh Morton decided not to continue this next year. Water Master Sager has interviewed several people to replace him. None of them wanted the job. A couple of other people were suggested.

With no further business the meeting adjourned at approximately 7:33 p.m.

- **3) Be it resolved** that Water District #74 will bill each water user a minimum of \$15.00 plus \$5.00 clerical charge.
- **4) Be it resolved** that Water District #74 will charge interest on delinquent assessments at 12% per year with a minimum of \$5.00 per month.
