# Water District 29 H 2021 Watermaster Report By: Kristin Evans

- The Total Volume (Acre Feet) of water delivered to water users in the district was 13,270.63AF. This number is derived from measured diversion and estimates for water users that did not have measuring devices installed. Estimates were calculated based on the acreage of the water right x 3.5 AF.
- Point of Diversions that did not have measuring devices installed that I verified received a Failure to Comply with Order Requiring Controlling Works and Measuring Devices letter from Steve Visosky at IDWR. This season there was a potential 243 points of diversions that could divert more than 5 acres.
  - 43 points of diversions had measuring devices.
  - 147 had approved extensions or have measuring devices at other points of diversions.
  - 53 points of diversions need measuring devices.
- The Total Expenses billed for the district was \$ 25,763.34
- The Total Number of Days I worked was 176 as of December 13th, 2021.
