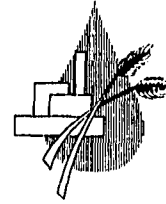

CLAIM TO A WATER RIGHT



Under the provisions of Section 42-243, Idaho Code, any person using or claiming rights to the public waters of Idaho established by diversion and application to a beneficial use must file a claim with the Department of Water Resources on or before June 30, 1983. Exempted from this filing are single family domestic uses as defined in Section 42-230(d), Idaho Code. Also exempted are rights represented by a permit, license, decree, adjudicated right, or a previously filed claim.

The filing of this claim does not confirm the water right claimed but failure to file may result in forfeiture of a water right.

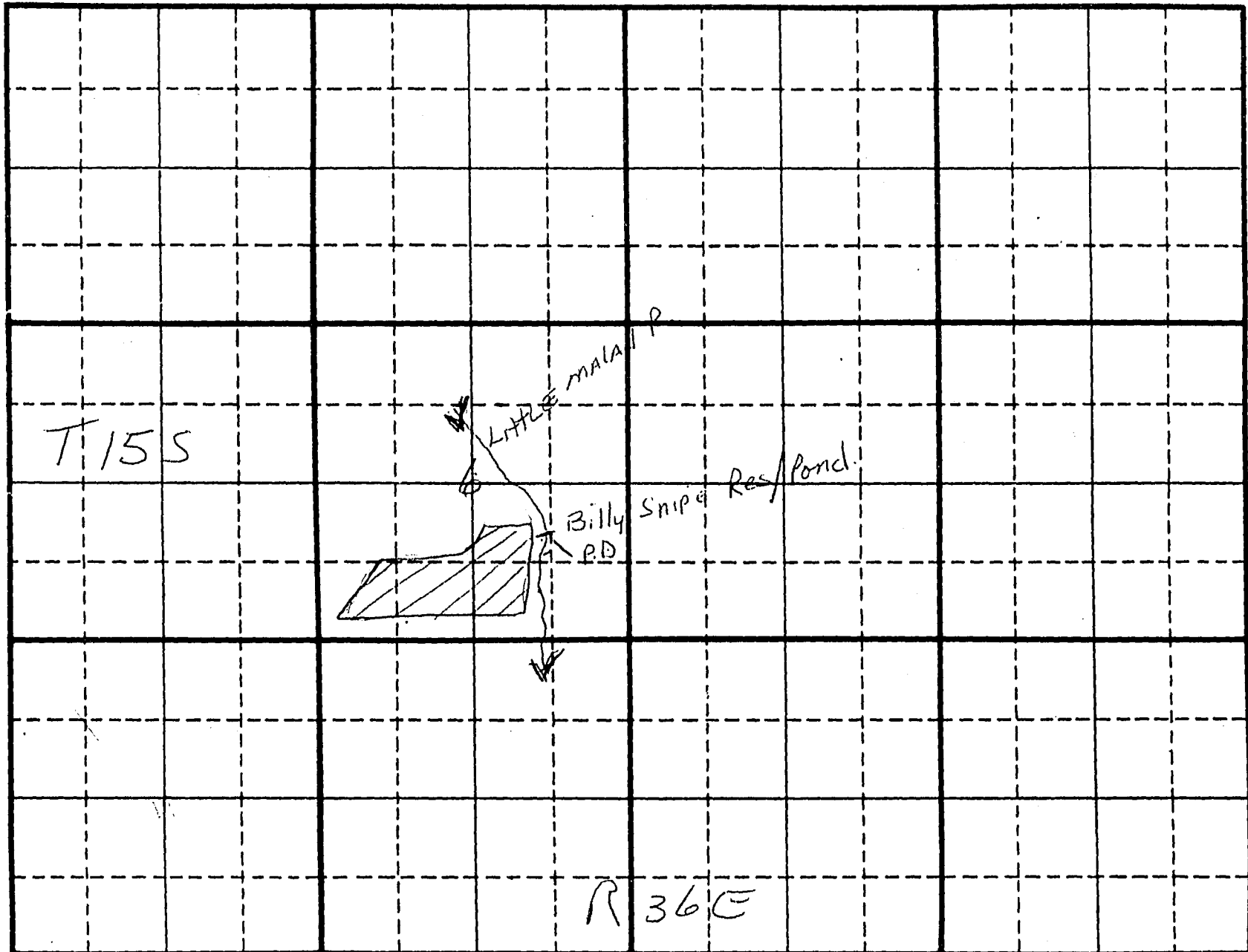





Dear Mr. Blaisdell:

I am returning one of your recently submitted claims. Please note that the filing fee per claim is \$30.00. Please resubmit the enclosed claim with the \$30.00 filing fee and we will begin processing it. We have initiated processing of your other claim.


I researched the possibility of a filing on the Big Malad River for your property in Lot 3 and the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Sec. 18, Twp. 15S, Rge. 36E. The only filing I found near the area is a claim filed by Evan P. Price. Price's claim on water from the Big Malad River does not pertain to your property. I found no listings of filings by Levi Waldron, David R. Edwards, or Thomas Jenkins.

Unfortunately, my office does not have a complete file of water rights. You should probably do some research of your own at your county courthouse to see if any listing of your water use exists there.

If you do not find any record of your water use, you may wish to contact the other three users and together with them file a claim on the water (if the use predates May 20, 1971) or an application for permit (if the use is after May 20, 1971). The priority date of the water use must be documented. I am including a blank claim and instructions in the event you and the other users wish to file.
