

Water Master Annual Report 2025

To Whom It May Concern:

The 2024 water year was a year of learning and inventory.

Initial inventory has happened on 71 Points of Diversion across the water district.

It was surveyed that most are absent of water meters, and if they do possess a measuring device it has evidence of malfunction or improper installation. Water users are encouraged to update the measurement device on their system as the IDWR is expected to make this a requirement in the near future.

Out of the 71 surveyed sites, there were 2 unable to be located, sites 261295 and 336580

Most points of diversions meet the requirement of our jurisdiction, but we are seeking clarification on minor sites that could fall under the domestic/ culinary well criteria.

Budget wise, the WD13T has sufficient funds going into 2025, which I suggest we adopt the same budget outline used in Fiscal Year 2024. This will ensure that we can operate within the requirements and expectations of the IDWR. Until the measurement device requirements are set, we will look to distribute assessments according to water rights rather than water usage.

In 2025 we look forward to a year of learning and progressing as a water district with the help and guidance of the IDWR.
