2021 Watermaster Report

- The Total Volume (24 HR CFS) of water delivered to water users in the district was 3928.70 24HR CFS. This number is derived from measured diversion and estimates for water users that did not have measuring devices installed. Estimates were calculated based on the 24 HR CFS of the water right x 85 days.
- The amount of water recorded for the City of Pocatello was from January 1st until December 31st for the 2021 season. New 29D Resolution changes were made for the upcoming seasons. The amount of water recorded for 2022 will be from January 1st until October 31st.
- Point of Diversions that did not have measuring devices installed that I verified received a Failure to Comply with Order Requiring Controlling Works and Measuring Devices letter from Steve Visosky at IDWR. This season there was a potential 258 points of diversions that could divert more than 5 acres.
 - 42 points of diversions had measuring devices.
 - 60 had approved extensions or have measuring devices at other points of diversions.
 - 48 points of diversions need measuring devices.
- The total expenses billed for the district was \$ 18,800.00
- The total number of days I worked was 78 days as of December 14th, 2021.
