ADVISORY COMMITTEE: James Whittaker motioned to retain the current Advisory Board and Credentials Committee. Carl Ellsworth seconded. Motion passed. Advisory Board and Credentials Committee: Jordan Whittaker, Carl Ellsworth, and Ralph McRea

WAGES FOR WATER MASTER AND SECRETARY/TREASURER: Carl Ellsworth motioned to increase the water master's salary to \$700.00 per month and increase equipment rental to \$1,000.00 per month. Merrill Beyeler seconded. Motion passed. Jordan Whittaker motioned to set the Secretary/Treasurer wages at \$500.00 per year plus \$50.00 for postage and office supplies. Carl Ellsworth seconded. Motion passed.

FINANCIAL: District 74Z received \$8,500.00 in water bills and spent \$8,454.53on expenses in 2021. The district checking account earned \$0.45 in interest. The checking account balance for Water District 74-Z was \$1,800.70 as of January 31, 2022. Carl Ellsworth motioned to accept the financial report. James Whittaker seconded. Motion passed.

BUDGET: Carl Ellsworth motioned to set a 6.5-month budget of \$12,908.08 and assessing \$12,000.00 for the 2022 water year. Jordan Whittaker seconded. Motion passed.

INTEREST: There were no outstanding water bills. Ralph McRea motioned to retain the current interest rate of 10% on outstanding water monies. Merrill Beyeler seconded. Motion passed.

WATER MASTER: James Whittaker motioned to retain Merritt Udy as water master. Ralph McRea seconded. Motioned passed.

CHAIRMAN AND SECRETARY/TREASURER: James Whittaker motioned to retain Steven Johnson as chairman of Water District 74-Z and retain Douglas Beyeler as Secretary/Treasurer. Carl Ellsworth seconded. Motion passed.

#### **OLD BUSINESS**

Those present discussed on how to assist Merritt on the administration of water rights that he has questions on. It was decided to go first through the advisory board and if there are still questions then to check with IDWR.
