Board present: Craig Crandall, President, Jim Andrus Vice President Region Region Randy Morris, Bryon Allan, Lonny Dahlke, and Wayne Avery, Secretary/Treasurer.

Craig called the meeting to order at 2:00 P.M. and welcomed everyone and recognized Jared Adamson from IDWR. Reminded everyone to be sure to sign the attendance roll.

Craig asked for the minutes to be read, Brad Yates made the motion to accept minutes as read, Dan Davids 2nd it, motion passed.

Craig asked for the financial statement to be read, Tim Munn made the motion to accept the financial statement as read, Chet Davids 2nd it, motion passed.

Craig asked for a motion to vote water used in 2022 if needed, John Labrouche made the motion, Steve Toly 2nd it, **motion passed.**

Craig recommends Randy Morris, Jim Andrus, and Wayne Avery serve as the credentials committee, Tim Munn made the motion, John Hyde 2nd it, **motion passed.**

Craig asked for the proposed budget to be read for this year, Craig said the board recommends to ammend the proposed budget to not pay Idaho Water Users of \$125.00 and give Steve Hebdon a \$2,000.00 raise for expenses changing the total proposed budget to \$53,492.04 from \$51,617.04. John Labrouche made the motion, Brett Casperson 2nd it, **motion Passed.**

Craig said the board recommends we hire Steve Hebdon as the Water Master for 2023 with a 2 year contract and a one year renewal for the year 2023 with Kevin Hebdon and Linda Hebdon to serve as assistant water masters at no additional cost to the river district, also Steve Gravis to serve as an assistant water master to adjust one head-gate only with Steve Hebdon's permission. John Labrouche made the motion, Corey Fly 2nd it, **motion passed.**

Craig said the Board recommends we round water assessment to the nearest dollar and not use credit and debit system of billing. Darrell Christensen made the motion, Corey Fly 2nd it, **motion passed.**

Craig said the board recommends using resolution B for collections and use 2022 water figures for billing in 2023. Darrell Christensen made that motion, Lynn Stewart 2nd it, **Motion passed.**

Craig opened up the meeting for election of officers, Corey Fly made the motion to leave the board as is, Craig Crandall as President, Jim Andrus as Vice President, Randy Morris, Lenny Dahlke, Bryon Allen as board members with Wayne Avery as Secretary/Treasurer, Lynn Stewart 2nd it, **Motion Passed.**

Craig opened the meeting for other business, Jared Adamson answered questions about wells being measured.

John Hyde said the snow pack is 142 % of normal and the reservoir is 34 % full.

Randy Morris read a letter from his canal had drafted by Cris Robinson to be sent to IDWR about waiting a year before doing water cuts for Twin Falls to get things better in place, Randy said anyone that wants to can add their name to the letter, Ken Andrus said don't do that. Lowell Allan asked about measuring device on the flume, John Hyde said it will be up and running in May, Lowell also asked about the old portable measuring devices, Steve Hebdon said they could not be repaired, Lowell Allan made a motion that we purchase some new ones, motion failed, no second,

Glen Christianson brought up wasting water and flooding his meadow and asked if they could keep the water within the banks of the river. John Hyde said they do the best they can.

Discussed a measurement device at the head of the reservoir, Steve Hebdon said that spring run off just washes it out.

Tim Munn moved we adjourn, Lonny Dahlke 2nd it.
