Bruce explained that the green column was 24-hour sec. ft average of 5 years. Cost budget divided by total use of water times 24-hour average. There is a \$30 base fee for everyone. Also noted was that Big Flat had no measuring devices yet.

Before approval of the proposed budget for 2023, Watermaster Ron Johnson was asked if his salary and operating fees were sufficient. He noted that they were.

Discussion

Cindy Yenter, Idaho Department of Water Resources (IDWR) Salmon field office retiree, attended the meeting as a water user. She had information and shared the update from last year's proposed expansion plan. There's a big disparity, so IDWR will leave Salmon River main stem diversions out of the Carmen District. Tower Creek, 4th of July Creek and the North Fork are not the Carmen District, nor are any tributaries west of the Salmon River.

Cindy is willing to lend her expertise to us with any transitions. Big Flat re-diversion is still ours. Main diversion from river is not included in our district. We should only be adding 4-5 diversions to our Water District 75D.

It was noted that water districts cannot add true instream flow to water bills.

Dave McFarland mentioned he was originally opposed to the WD 170 expansion but likes the present formulation and cited examples of the need for regulation on small tributaries.

Resolution to set June 20th as the default due date for water user fees was discussed. The county does charge \$5.00 per billing for clerical purposes. 8% in late fees is charged to water users for overdue accounts. It is a standard collection that is paid to the water district. Motion to approve the default date and for Lemhi County Treasurer to collect fees as in the past.

Motion to approve. Seconded. Passed.

Adopted Resolution

The default date of June 20th for deadline for collection water fee dues. This coincides with tax assessor.

Additional Discussion

Cindy Yenter suggested streamlining voting on resolutions by printing them in a document that could be approved each year.

Other Business

Chairman Dave McFarland asked if there was any other business or any complaints about last year's water. No topics were raised.
