Chairman Haws called the meeting to order and welcomed everyone to the meeting.

Approval of

Minutes:

John Hartman moved, Michael Shippy seconded, to approve the minutes from the regular meeting on March 14, 2023, as presented. <u>Motion carried</u>.

<u>Watermaster</u>

Report:

- <u>- Storage lease commitments</u>-Watermaster Shippy went over the calculator he has set up for inbasin and out of basin commitments. He explained how it worked and went over what is needed for inbasin this year. He stated that the rules are different, and everyone will share in the inbasin requirement. He said that the Inbasin will be done on a pro-rata basis as to equally split it amongst all. After some discussion Carl Hayes moved, Michael Shippy seconded, to make an exception to the rule for the 2023 rule allowing any individual/entity to share above the pro rata requirement. Motion Carried.
- In-basin rental applications- Watermaster Shippy went over how in-basin rentals are supposed to work. He said that in-basin users should be renting their water at the beginning of the year but there are no applications yet. Ken Roberts asked for an explanation on how this works. Watermaster Shippy then went over the rules and expectations giving everyone a good understanding on how this works.
- Discuss rule changes starting 2024- Watermaster referred to pages 6-11 of the handout that talk about private agreements between a space holder and a user. Watermaster Shippy said there are ways to accomplish private agreements but there are no formal rules for it. The sense of the board was to have Watermaster Shippy put some ideas together for the rules and present them at the next meeting. John Hartman moved, Korth Elliott seconded, for Watermaster Shippy to come back to the next meeting with proposed wording for private agreements that would exchange out of basin. Motion carried.
- Discuss 2024 Rental Pool fees- The consensus of the board was to move this to the July 2023 meeting.

BOR:

Flow Augmentation water needed for 2023.- Ryan Hedrick stated he heard that originally the Bureau had the District down for about 61k acre feet but would take more if it was available. Ryan stated that he will double check on this figure and update Watermaster Shippy.

<u>Committee:</u> Rental Pool committee Members- Watermaster Shippy brought up the Rental Pool and how it is

run by a different set of rules then the Advisory board. His question to the Board was whether they want to leave it as it is, ran by the same advisory board or if they want to change it to those

members that are involved in the Rental Pool only. The consensus of the board is to leave it the

same and revisit this topic at another time.
