ORDER APPOINTING HEARING OFFICER

BACKGROUND

On April 25, 2024, the Idaho Department of Water Resources ("Department") received the City of Pocatello's Petition Requesting a Hearing on [Water District 01's] 2023 Storage Report ("Petition"). Pocatello states that the Water District 01's "allocation of stored water to Pocatello's space in Palisades Reservoir in 2023 was erroneous" and that Pocatello "has been aggrieved" by the allocation. Petition at 2. The Petition requests the Department initiate formal proceedings to address the issues raised by the Petition in accordance with IDWR Rules of Procedure 102 (IDAPA 37.01.01.102). Id.

ANALYSIS AND CONCLUSIONS OF LAW

Idaho Code § 42-1701A(3) provides in relevant part:

Unless the right to a hearing before the director... is otherwise provided by statute, any person aggrieved by any action of the director, including any decision, determination, order or other action... and who has not previously been afforded an opportunity for a hearing on the matter shall be entitled to a hearing before the director to contest the action.

Pocatello has not previously been afforded an opportunity for a hearing regarding Water District 01's allocation of storage water to Pocatello during the 2023 irrigation season. Accordingly, it is entitled to a hearing pursuant to Idaho Code § 42-1701A(3). The Director will grant the hearing request and appoint James Cefalo, IDWR Eastern Region Manager, as the hearing officer in this matter.

ORDER

IT IS HEREBY ORDERED that Pocatello's request for a hearing is GRANTED.

IT IS HEREBY ORDERED that James Cefalo is appointed to serve as hearing officer in this matter and is authorized to hear this contested case on behalf of the Department pursuant to IDAPA 37.01.410–414 and the provisions of chapter 52, title 67, Idaho Code. Hearing Officer
