On April 25, 2024, the City of Pocatello ("Pocatello") filed a *Petition Requesting a Hearing on WD01's 2023 Storage Report* pursuant to Idaho Code § 42-1701A(3). Pocatello's request for a hearing was granted on September 9, 2024, and James Cefalo was appointed as the hearing officer for the contested case. On August 7, 2024, Burley Irrigation District, Fremont-Madison Irrigation District, and Idaho Irrigation District (collectively "Districts") filed *Spaceholders' Combined Motion to Intervene & Memorandum in Support of the Motion to Intervene*. The Districts' Motion to Intervene was granted on October 10, 2024.

On October 7, 2024, the Cities of Bliss, Burley, Carey, Declo, Dietrich, Gooding, Hazelton, Heyburn, Jerome, Paul, Richfield, Rupert, Shoshone, and Wendell filed *Coalition of Cities' Motion to Intervene and Memorandum in Support*. The response period described in Rule 354 of the Department's Rules of Procedure (IDAPA 37.01.01) has not ended so the hearing officer has not acted on the Coalition of Cities' Motion to Intervene.

The department has scheduled this matter for a prehearing conference on **December 9**, **2024**, at 1:00 pm.

Agenda items for the prehearing conference will include:

- 5. Designate target date for conducting administrative hearing if resolution is not possible during the prehearing conference, and
- 6. Address other matters that may expedite orderly conduct and disposition of the proceeding.

It is important for all parties to give considerable thought to each of these matters before appearing at the prehearing conference.

The Department encourages the parties to discuss and resolve the concerns before the prehearing conference. If private discussions are not possible or they do not resolve the concerns, the Department's Rules of Procedure provide for a prehearing conference to be held before scheduling a formal hearing.

The prehearing conference will be conducted in a facility that satisfies the accessibility requirements of the Americans with Disabilities Act. If you require special accommodation in order to attend, participate in, or understand the prehearing conference, please notify the Department at least ten (10) days prior to the hearing.
