Water district 37-0 has a minimum water usage fee of \$50 Bruce would like his usage documented

Julie Smith nominates Luke Smith has water master Sherry Price 2nd motions Motion passed

This year has potential for a lot of water If weather is warm quickly it could come fast

Julie Smith nominated Landon Smith as deputy water master Brian Bean requesting background information on Luke and his qualifications

Luke Smith attended and graduated from the College of Southern Idaho with an Agricultural science degree. Has taken classes with Jeff Cooper. Jeff teaches and trains Dept of Water Resources. Luke also has taken classes water management classes. How to measure and control water flow. Luke was deputy water master last year. Luke will be living near Rigby area.

Possible talk of Bruce Price being deputy water master. He declined.

Bryan Smith gave appreciation to Bruce and Sherry for living on site all year

Bruce will assist the Luke and Landon

Brian Bean will abstain from voting for Landon since he does not know him

Bruce 2nd motion for Landon as deputy water master

Mary proposed Julie Smith as treasurer Sherry Price 2nd the motion Motion passes

Confusion on John Langston only billed for 4% water usage. Could be inaccurate reporting. Will reassess and amend if necessary.

Resolutions pass as proposed

Water master report by Brandon Smith Improved knowledge by Brandon Devices were in good shape 20 years problems with Guy Petersons head gate He was tagged last fall. It must be brought up to code/main diversion

Guy Peterson was tagged by the Water Dept. on March 31 He can not be turned on until this is repaired. How will this happen? Possible high water and flooding/washed out

Bruce Price prosed we give Guy Peterson a deadline for fixing weir and shut off gate.

July 31 2023 in the deadline

July 31 is a fair date due to snow levels

This should have been done in the Fall but was not

A measurable amount of water is going under weir all times and at the head gate leaks and water goes under that. At least one or two CSF

This repair could be completed in one day according to Bruce

A letter had been sent in September and nothing has been done

Guy was cited in November and was given the date of March 31 to have all repairs made

An open enforcement case is open and active with the Dept of Water Resources

If nothing is done then he will be cited and penalty fine and shut off. Full curtailment will be activated. Fines will be assessed. The fine now is \$3000. Will increase if it is not fixed.

In order to shut the water off a backhoe would have to been taken up to the site.

SCANNED MAY 01 2023

The water master will need to inspect and see what if anything has been fixed and will be accompanied by the Department of Water resources.

John Langston and Brian Bean will draft a letter from the committee

Luke Smith ,the water master, will send a letter

Idaho Department of Water Resources will send a letter

The secretary will send out minutes after all other letters have been sent

The logistics of the steps that will happen if this is not resolved:

- 1. Corey will contact his superiors
- 2. Enforcement case will be enforced and fines assessed
- 3. Sheriff would be sent
- 4. Court case would follow

A letter should be sent stating that the day has come and gone for the deadline in March.

We as a Water District will allow a date of July 31 to be the final deadline.

Water data for April 4 -136% The Big Wood/Camas Prairie has the highest density of water to snow ration in Idaho Goal for future : No more issues with illegal diversions No other business Corey motions to adjourn meeting Motion passes
