As anticipated, the 2023 irrigation season was exceptionally good. Deliveries were up significantly from 2022 and the irrigation season was extended markedly for most water users. There were, however, some strange trends to the year, as discussed below.

Many laterals were drifted with snow and ice such that most water calls were delayed by a month or more from the previous couple of seasons, but with little or no adverse impact due to high soil moisture and Spring precipitation. Also, despite a huge volume of runoff and available water, many users simply did not need the water for much of the early season due to the saturation and some timely precipitation events. When streamflows did begin to drastically diminish during the second week of July, many irrigators were caught off guard, but had still enjoyed an excellent irrigation season. Considering the runoff, billable water deliveries were surprisingly low owing to low average demand throughout Spring.

Again carrying ahead the same budget amount as the previous three years for 2024, David and myself did not request any increase in compensation. Apportionment of \$5.238 per unit last season, based on the five-year average, will be only slightly higher at \$5.533 for 2024.

Like 2023, snow pack looks very promising for the irrigation season ahead. Above average snowpack, coupled with rain-on-snow events have again increased the stored moisture both in that snowpack and valley soils.

Large storms with high winds continue to pile snow in canyons and draws, although there is now way of knowing how the later runoff will occur. Winter runoff is observable around the valley, but hopefully, continued high elevation snowfall, valley rains, and gradual Spring runoff will lead to a season as good as last year.

2023 was free of major mishaps and conflicts with the minor exception of Merriman's new measurement device on Spring Creek washing out. To the best of my knowledge, water users have worked together as needed to maintain laterals and diversions in decent condition. Disturbance by cattle and saturated conditions did present some challenges on the Vaughn Ditch. I do not know the status of any '23 post or '24 pre irrigation season maintenance on the Vaughn which might avoid delivery issues in the coming season.

IDWR reached out to me last season with a watermaster training opportunity which I was unable to attend. Depending on timing and ability, I will make every effort to take part in future such trainings.

As Table 1, "Five Year Totals and Averages" illustrates, 2023 billable water deliveries were roughly 18 % higher (853 24 Hr sf) than the previous year. Deliveries are expressed in 24-hour second feet (1 cubic foot per second over a twenty-four hour period), equal to 1.9835 acre feet. The proposed budget divided by the five-year-average yields an apportionment factor of \$5.533.
