A motion was made and seconded to keep the officers the same; all were in favor.

The secretary read the minutes from the 2022 meeting. A motion was made and seconded to approve the minutes; all were in favor. The secretary informed the members that Columbia Bank is merging with Umpqua Bank. They will keep our account as is and the current total is \$896.86.


The next meeting will be held on Tuesday March 5, 2024, at the home of the Watermaster, Randy Davison.
