

The Annual Meeting of District 65-D was held on March 6, 2023 at 10 a.m. at the Donnelly Bible Church.

Users present – Isaac Babcock; David Carey; John Duncan; Linda Duncan; Nate Gilliam; Dick Kleint; Gretel Kleint; Bill Nikkel; Robert Oxarango. Others – Kristi Kessler (Secretary Roseberry Irrigation District); Scott Storm and Steven Visosky (IDWR); James Siewert (Watermaster District 65-D); Neil Shippy (Watermaster District 65).

1. The minutes of 2022 were read. Robert moved and Bill seconded to approve the minutes as read. Passed
2. Treasurer's report was \$3,628.92 in the checking account. Outstanding bills: Michelle Anchustegui-\$185; Craig Curtis-\$25; Eld Ranches-\$10; Ed Freeburg-\$25; Patrick Harren-\$65; Dave Splan-\$25. Isaac moved and Bill seconded to accept this report. Passed
3. Bill moved and Dick seconded to have next year's meeting on the first Monday of March at 10 a.m. at the Donnelly Bible Church. Passed
4. Bill moved and Dick seconded to continue 65-D's membership with the Idaho Water Users Association at \$50. Passed
5. John moved and Dick seconded to have the advisory board of – Isaac Babcock, David Carey, and Bill Nikkel. Passed
6. Bill moved and Isaac seconded to have **David Carey – Chairman.**
7. Isaac moved and David seconded to have **Linda Duncan – Secretary/Treasurer**, \$400 plus \$150 for office supplies. Passed; Robert moved and Dick seconded to amend to \$450 plus \$200 for office supplies. Passed
8. Isaac moved and Bill seconded that the following resolutions be continued:
 - *"Resolved, that no Ditch, Canal Co. or other Water User shall have the right to demand and receive water and the Watermaster shall not deliver water to such user, until the amount due and payable from such user, as set by the budget, has been paid."*
 - *"Resolved, that no water will be delivered to party or parties that the Watermaster deems responsible for the maintenance of a weir or measuring device until the weir or measuring device is repaired/replaced to the Watermaster's satisfaction."*
 - *"Resolved, that new developments leave an easement for companies and districts to be able to clean and maintain the ditch/canal and to have access for the ditch rider: accessible, unlocked gates a minimum of 12' and as in accordance with Idaho Code Ch. 11 – Rights of Way."*
 - *The attached letter (Idaho Codes § 42-1201; § 42-1202; § 42-1204; § 42-1209; § 43-304; § 43-327) written by Dana Hostetter (water lawyer) as resolutions.* Passed
9. Robert moved and Dick seconded to adopt the budget of \$8,371; Watermaster -- \$6,000 and \$750 for vehicle and that **James Siewert** be elected/hired as **Watermaster** for Water District 65-D. Passed
10. Dick moved and Isaac seconded to change the annual recording fee of \$25 to \$30. Passed
11. Robert moved and Isaac seconded that the meeting be adjourned. Passed
