The annual meeting of Water District No. 65-K was held on March 6, 2023 at 1:00p.m.at the Donnelly Community Center in Donnelly, Idaho.

The meeting was called to order by Justin Florence. Art Troutner nominated Will Maki as chairman for the meeting. Will nominated Laura Bettis for chairman. Laura Bettis nominated Shirley Florence as Secretary-treasurer. Art Troutner made a motion to appoint Laura Bettis as Chairman for the meeting and Shirley Florence as Secretary-Treasure. The motion was 2nd and carried.

The following business was transacted:

1. The minutes of the March 7, 2022 meeting were read. Ben made a motion that the minutes be approved. It was 2^{nd} and the motion passed.

2. The financial report was presented. The balance on hand is \$9614.89, of which \$5130.73 is 65K's balance. Art made a motion to accept the financial report. It was 2nd and passed.

6. Shirley read the following resolution pertaining to the collection of water user fees as set by the budget: "The water users of Water District No. 65-K do hereby resolve: that no ditch or canal company, or other water user shall have the right to demand and receive water, and the water master shall not deliver to such water user, until the amount due and payable from such user, as set forth by the budget, has been paid." Ron Platt made a motioned to accept the resolution. It was seconded and the motion passed.

7. Justin nominated John Leedom as watermaster for the coming year. The nomination was 2^{nd} by Ben Rydalch. John was elected by unanimous vote.

8. Chairman Laura appointed the following to the advisory committee:

Will Maki, Katy Jones, and Laura Bettis.

9. Report for the 65-K Rental Pool was presented: 397.74 acre feet of water was rented out. There is an accumulated balance of \$4484.16 in the rental pool account.

The next meeting will be March 4^{h} 2024 at 1:00pm at the Donnelly Community Center. With no further business, Michelle motioned to adjourn the meeting. It was seconded and the motion carried. The meeting adjourned at 1:20 p.m.
