Enclosed is your certificate of appointment as Assistant Watermaster of Water District **61-C**, **BENNETT CREEK**. Per Idaho Code Section 42-608(1), the watermaster's term of service "...*is throughout the year, extending until the annual meeting for the ensuing year, or until a successor is appointed.*" Based on the code, the watermaster's appointment is from one annual meeting to the next, generally speaking.

Per Idaho Code Section 42-609, a watermaster shall have power to employ suitable assistants to aid the watermaster in the discharge of the watermaster's duties.
