#### Water District 11-B Minutes

#### March 5, 2018 10:02AM

#### Caribou County Court House Downstairs Conference Room

Annual water board meeting was called to order

Those in attendance Sharla Cox, Idaho Department of Water Resources Idaho Falls, Steve Visosky, Idaho Department of Water Resources Boise; Eric Simonson Farmers Land & Irrigation Representative; Alan Skinner City of Soda Springs Representative, Kristen Skinner water user; Jason Maughan Monsanto Representative; and Bonnie Barfuss water user & District secretary.

Idaho Department of Water Resources Representatives came to this year's meeting as courtesy to help us get up and running since the chairmen quit and the Watermaster retired. This district was in limbo. The representatives gave an overview of how a Water District should be organized and run with regards to Idaho Statutes. Water District 11-B has been using an old outdated meeting guideline which reflected incorrect information and member titles.

<u>Election of meeting chairman:</u> Alan Skinner nominated Kristen Skinner and Eric Simonson seconded the motion. Motion carried. Kristen Skinner is the daughter of Robert and Nedra Torgensen (both deceased) and has their water rights transferred to her name.

Election of Water District Watermaster: Bonnie Barfuss nominated Brandon Harris, a city employee. Alan Skinner seconded the motion. Due to Last Chance Canal obligations Wes Long was not considered as a Watermaster candidate as previous discussed last year. Steve discussed the Watermaster duties as far as personal vehicle, insurance and workman's compensation and what the Water District's business dealings with the Watermaster.

Election of Secretary and/or treasurer: Eric nominated Bonnie Barfuss and Alan Skinner seconded the motion. Secretary will be writing and submitting the annual meeting minutes. Bonnie Barfuss will mail out water user assessment billings, collect funds, and issue payment to the watermaster. Water District 11-B will be company name so checks can be deposited and written out of the account.

Approval of adopted budget: Alan Skinner nominated that the budget stay the same as it has been in the past. Eric Simonson seconded the motion. Moneys were collected from all users except Monsanto from last year. This will be deposited into the new account with Craig Hill and Brandon Harris receiving a percentage along with the Secretary. Mileage amount will stay into account.

Approval of Annual Meeting Minutes: There were no minutes due to there not being a second water district meeting.

New resolutions will be created at next year's meeting with the advisory committee on March 4, 2019 at 9:30AM in the Caribou County Courthouse downstairs conference room. Annual meeting will follow at 10:00AM.
