8/1 – 8/2/17

Ryan McHugh called, concerned that JC was watering with Porter Creek when the supply was down and he had a higher water right. Talked to JC Fry/Randy Heffner, he was using Porter Creek water, but only because no one else was calling for Porter Creek water. JC turned off when this issue was brought up to him.

8/13/17

JC Fry didn't see anyone watering with Porter Creek water and was wondering if he could use it. I called Ryan McHugh to see if Double Diamond needed it, he informed that that yes, they were watering 24/7. I drove down and checked and they were watering so I informed JC that he couldn't use Porter Creek water.

8/15/17

Ryan McHugh called and was concerned that the person at the end of Pioneer Road (68 Pioneer) was watering and wanted to make sure he wasn't using Porter Creek water. I went down and talked to him, his name is Brandon Howerton. He was watering but he was pulling water from the Payette River and said he had the water right, it was 65-22764.
