



RESOLUTION A

RESOLVED, that the water users of Water District #63 do hereby agree to vote by acclamation the resolutions to be adopted in this meeting, unless a request is made by a qualified voter to vote on any resolution by casting a roll call vote counting the numbers of voting shares: each person or corporation with a right equal to the average annual dollar amount and any fraction thereof assessed for that water right for the previous five years.

RESOLUTION B

A motion to be made and seconded, that the budget, to include Resolutions I and J be adopted as read and that the items of salary and other expenses be fixed as contained therein.

RESOLUTION C

A motion to be made and seconded, that _____REX R. BARRIE_ Be authorized to serve as Watermaster for Water District #63 from the election at this annual meeting until the next election at the next annual meeting.

RESOLUTION D

A motion to be made and seconded, that the Watermaster shall be authorized to appoint such assistants as are necessary, and for such time as may be necessary, for the sufficient distribution of water of Water District #63 for the ensuing year.

RESOLUTION E

A motion to be made and seconded, that the costs be determined by the total amount of water delivered to each canal, both storage and natural flow, and that the Secretary/Treasurer be authorized to collect the Watermaster's Tax directly from the water users in Water District #63.

RESOLUTION F

A motion to be made and seconded, that the amounts payable by each ditch, canal company or other water user, as shown by the approved budget, shall become due and payable on April 10th of this year and said amounts, if not paid, shall bear interest from that date until paid at the rate of 8% per annum, and that no ditch canal company or other water user shall have the right to demand and receive water, and that the Watermaster shall not deliver water to such person until the amount of the tax due and payable from such user, as fixed by the budget, shall be paid.

RESOLUTION G

A motion be made and seconded, that the Chairman, Secretary/Treasure, and Advisory Board Members be elected by the water users to serve from this annual meeting until elected at the next annual meeting.

RESOLUTION H

A motion to be made and seconded, that the water users of Water District #63 pay the necessary expense for the Watermaster to attend the State and National Water Users Convention and any other meeting that are necessary for the ensuing year.

RESOLUTION I

All budget items except wages and benefits shall be paid thru the MMI account. (Wages and benefits are paid thru the assessments.)

RESOLUTION J

That two signatures shall be required on all checks, and that the Chairman, Secretary/ Treasure and the Watermaster shall be authorized to sign said checks.

Lucky Peak Dam and Reservoir O&M Costs

Background

- Lucky Peak Dam and Reservoir is owned and operated by the U.S. Army Corps of Engineers (USACE) for flood risk management, water supply, recreation and fish & wildlife
- Reclamation is authorized to contract for water storage at USACE facilities
- Reclamation has contracted with approximately 20 entities (Contractors) for a total of 71,018 AF
 of storage in Lucky Peak Reservoir
- Contracts require Contractors to pay their proportionate share of the Lucky Peak operation and maintenance (O&M) costs based upon their percentage of active capacity ("space-based")
- In early 2017, Contractors requested Reclamation review the methodology it uses to determine the O&M rate

Rate Methodology for O&M Costs


- Beginning in 1982, Reclamation established a rate methodology based on categories of costs that was unique to Lucky Peak and not easily understood
- Based on the request from Contractors, Reclamation updated the rate methodology to a space-based approach in 2018:
 - ✓ O&M costs will be categorized as joint or separable, consistent with practices at other reservoirs and as described in Reclamation Manual policy
 - ✓ Reclamation will apply a space-based rate to all <u>joint</u> costs and to <u>separable</u> costs related to O&M for purposes of storing and releasing water under the terms of the contracts
 - ✓ Reclamation will not include <u>separable</u> costs related to other purposes (e.g., recreation management and fish & wildlife)
- The use of space at Lucky Peak Reservoir is as follows:

Flood Control (278,200 af)	48.7%
Water Supply (71,018 af)	12.4%
Streamflow Maintenance (152,300 af)	26.7%
Recreation (28,800 af)	5.0%
Flow Augmentation (40,932 af)	7.2%
Total <u>Use</u> of Space (571,250 af)	100.0%

^{*} Active capacity is 278,200 af. Space is designated for more than one use

Planning for Annual O&M Charges

- Lucky Peak Dam facilities are reaching an age requiring major non-routine O&M activities
- Reclamation and USACE will provide Contractors 5-year planning projections for known non-routine O&M activities that may significantly impact the billing rate (e.g., bulkhead hoist system, slide gate cylinder repairs, emergency gate hoist replacement, fire suppression line)
- Reclamation will send 2019 billing rate notice letters to Contractors in January letters will include 2019 bill amounts and billing rate projections for the next four years

WATER DISTRICT #63 2109 ADVISORY COMMITTEE MEETING DECEMBER 11, 2019 STAR CITY HALL

Chairman Vernon Case called the meeting to order at 1:03 P.M. There were 6 guests at the meeting. Committee members present Vernon Case, Sam Rosti, Richard Durrant, Alan Newbill, Jim Payne, Larry Story, Mike Houston, Clintion Pline, Roland Springer, Martin Galvin, Randy Davison and Ray Nebeker. Guest: Bob Carter, Tom Rithaller, Ron Platt, Bryan Horsburgh. Matt Anders and Matt Weaver with IDWR

Minutes: Chairman Case asked for the minuities to be reviewed and approved. Motion to approve the minutes was made by Richard Durrant and second by Allen Newbil passed all in favor.

Barber Dam Water Call: Chairman Case asked Rex Barrie to go over the water call on Barber Dam. Rex gave an overview of the dam outages and explained to the committee that there were 2 notice of violations levied against Ada County and ENEL. Rex also informed the committee that he and Mike Meyers would be meeting with ENEL the week of the 16th to discuss ENEL plans for fixing the problem.

Elmore County Water Right and Cat Creek: Chairman Case asked Matt Weaver with IDWR to give an overview of Elmore County Water Right. Matt informed the Committee that the water right for Elmore County had been approved and that Elmore County had 5 years to start the building of the project and show beneficial use on the water right. Matt also stated that Elmore County could file for an extension if they do not make any progress. Elmore County's water right is for 200 CFS and 10,000 AF total storage out of Anderson only during flood control operations. Matt also spoke on Cat Creek project and informed the committee that there water right had not yet been approved by IDWR. There was no new information to report.

Anderson Ranch Dam Raise: Chairman Case asked Roland Springer to speak on Anderson Ranch Dam Raise. Roland informed the committee that the EIS study is still on going and that the study should be released in February to the public. Roland also stated that the Idaho Water Recourses Board has filled for the water rights on the Anderson Ranch raise. Roland informed the committee that the project cost could be released as early as the fall of 2020.

Arrowrock Clam Shell Gates: Chairman Case asked Rex Barrie to speak on the Arrowrock clam shell gates that failed this summer. Rex gave an overview of what happened on the clam shell gates. Rex informed the committee that the water that went past the Middleton Gage due to the failure of the clam shell gates would be charged to operational loss until the Bureau of Reclamation can make a decision on where the water will be charged. Roland informed the committee that the hydraulic lines will be replace every 5 years going forward the lines that failed where on the gates for 10 years.

Weather Modification: Chairman Case asked Rex Barrie to talk about weather modification. Rex informed the committee that our agreement with Idaho power will end this water season and the committee needed to decide if they want to continue with cloud seeding. The committee decided that they did want to continue with cloud seeding a motion was made by Richard Durrant and second by Jim Payne motion passed all in favor.

New Business:

Winter Stream Flow Maintenance: Chairman Case asked Rex Barrie to speak on winter stream flow maintenance. Rex informed the committee that Idaho Fish and Game is looking at changing the flow regimen on the Boise River during the winter months to help improve the fishery on the Boise River. Rex also informed the committee that fish and game would like to make a presentation at the annual meeting to go over their proposal for possible change in the flows.

Fill/Refill Accounting: Chairman Case asked Matt Anders with Idaho Department of Water Recourses to give his presentation on Refill 1 & 2 accounting process. Matt informed the

committee that refill 1 & 2 have water right numbers associated with them now and that they are now in accounting the new water right numbers are 63-33734A and 63-33734B. Matt informed the committee that these new water rights will be used by the Bureau of Reclamation to turn flood control on and off in the accounting. BOR will need to let the watermaster know when flood control will be on and off and then the watermaster will change the accounting accordingly.

Resolutions: Chairman Case asked Rex Barrie to review the resolution's and the changes to resolution F, I, and J. Rex reviewed the changes and there was a motion to adopt the resolutions as corrected by Clinton Pline and second by Richard Durrant motion passed all in favor.

Dixie Slough Water Call: Chairman Case asked Rex Barrie to speak about the Dixie Slough water call. Rex deferred the topic to Mike Meyers. Mike gave the committee an over view on what happened with the city of Boise and what the water call means for the administration of the Dixie Slough. Mike stated that there will be added time to the route every week on checking diversions and that there could be up to a dozen new diversions that Water District 63 could have to administer this upcoming water season. Rex gave an overview on how this water call happened. Rex also told the committee that Greg Obendorf will receive a notice of violation for not installing a weir on his diversion off the Dixie.

Advisory Committee: Chairman Case informed the committee that he is stepping down from the Advisory Committee of Water District 63 effective at our annual meeting January 11th 2020. Vern suggested his replacement to be Ron Platt. A motion to have Ron Platt on the Advisory Committee was made by Richard Durrant and a second by Clinton Pline.

Watermaster Report: Chairman Case Asked Rex Barrie to give the Watermaster's report. Rex Gave an overview of the Watermaster's report. Rex also went over the Profit and Loss for 2019 through December. Rex then went over the new budget for 2020. Rex than gave an over view of the auditor's finical report. There was a motion made to accept the Watermasters and audit report by Richard Durrant and a second by Ray Nebeker passed all in favor. The Committee went into executive session at 3:00 and returned to open meeting at 3:20.

Deputy Watermaster Report: Chairman Case asked Mike Meyers to give the Deputy Watermaster's report. Mike gave the committee an over view of the progress in the upper basin and what next year will look like in the upper basin.

Marty Galvin asked the Chairman and the committee if Water District 63 if we would be donating to Karen Edwards retirement. It was decided that Water District 63 would donate \$500 to her retirement. A motion was made to approve by Marty Galvin a second by Mike Houston and passed all in favor.

There being no further business the meeting was Adjourned at 4:06 P.M.

The intent of this letter is to provide joint written instructions from the U.S. Bureau of Reclamation (BOR) and Idaho Department of Fish and Game (IDFG) to the Idaho Department of Water Resources (IDWR), for conveyance to the water master, regarding release of streamflow maintenance pursuant to water right 63-03618. Historically, a winter release of 240 cfs is utilized from the water right when the streamflow maintenance water supply is adequate. Given the adequacy of the water supply in 2019, BOR and IDFG request that 240 cfs be held in the Boise River over the winter of 2019-2020 beginning no later than November 1, 2019.

WATER DISTRICT #63 MINUTES OF THE ANNUAL MEETING JANUARY 7, 2019 Star City Hall, Star, Idaho

Chairman Vernon Case called the meeting to order at 1:04 P.M. There were 55 water users and guests at the meeting.

Chairman Case asked Rex Barrie to inform the water users about Oscar Baumhoff retiring from the committee and he has asked that Ray Nebeker replace him.

Minutes: Chairman Case asked if anyone wanted the minutes read. No request was made to read the minutes. Brian McDevitt moved to accept the minutes. Second by Richard Durrant. Motion passed with all in favor.

Roland Springer, US Bureau of Reclamation:

Roland talked about the current cloud seeding program and said from the BOR's point of view it was a successful program. The Federal Government shutdown has not affected the Bureau, as its budget was approved earlier in the year. The Department of Interior has begun a reorganization process that the Regional and Snake River offices will has to participate in. the Columbia River Treaty process is moving forward but with little information being made public. Roland also reported on the Boise River Feasibility study to look at increasing storage behind the three existing dams on the system. Priority has been given to Anderson Ranch as it has the most cost effective review. If Anderson is raised by 6 feet it would increase capacity to 29 KAF. Early cost estimates are approximately \$2000.00 per acre foot. This amount will change when final numbers are calculated.

Cat Creek still has not been funded so the BOR will not begin the feasibility study until they receive funds from Cat Creek.

Roland also report on the O&M costs associated with Lucky Peak. They have worked on these costs with space holders to try and lower annual costs.

Adopt Resolution A: Brian McDevitt moved to adopt resolution A. second by Richard Durrant. Motion passed with all in favor.

Elect Secretary: Jim Payne moved to elect Sam Rosti as secretary for 2019. Second by Neil Allison. Motion passed with all in favor.

Elect Chairman: Oscar Baumhoff moved to elect Vernon Case as Chairman for 2019. Second by Richard Durrant. Motion passed with all in favor.

Elect Advisory Committee: Rex Barrie explained that Oscar Baumhoff was stepping down from the committee and asked that Ray Nebeker be appointed for his position. It was moved by Oscar Baumhoff to appoint Vernon Case, Sam Rosti, Jim Payne, Randy Davison, Clinton Pline, Alan Newbill, Martin Galvin, Mike Houston, Larry Story, Richard Durrant, Ray Nebeker and Roland Springer to the Advisory committee. Second by Ron Sedlacek. Motion passed with all in favor.

Watermasters Report: Rex Barrie reported on the 2018 water year including snowpack, run off, day of allocation, rental pool operations and financial statements. All storage accounts were considered filled by the Flood Control Committee. (Watermaster, Boise Project Board of Control and Bureau of Reclamation) the day of allocation was June 12, 2018. Flood control operations began on March 21, 2018 and ended on June 11, 2018.

Storage at the end of December was 429,094 acre feet in the system.

Rental pool operations were reported at, 65,016 acre feet for flow augmentation, 40,932 AF from the BOR, 20,754 AF was leased to BOR from space holders and 3330 AF was leased for in basin use.

Bank balances at the end of December were reported as follows. Money Market \$630,855.03, Checking \$9,209.76 and State Investment at \$49,576.43. Rental Pool payments will be \$409,428.00 to space holders and \$34,440.12 to the Idaho Water Resources Board. After payments are made the balance in the money market account will be \$196,196.67

The committee hired Mike Meyers as Deputy Watermaster and began work on January 2, 2019.

Rex also reported on the cost of the Black Book Watermasters report and that he would be looking into putting the report on CDs next year to cut costs on the printing and binding of the reports. 15 books cost the district over \$800.00. Gail Glasgow Moved to accept the Watermasters report as presented. Second by Mike Houston. Motion passed with all in favor.

Budget Review and Approval: Chairman Case asked Rex to present the budget review and the 2019 proposed budget. After review it was moved by Brian McDevitt to adopt the 2019 budget as presented. Second by Ron Platt. Motion passed with all in favor.

Old Business:

Chairman Case introduced Mike Meyers and asked him to tell the water users a little about himself. Mike stated that he was from Idaho and had worked in the water arena for Pioneer Irrigation District and was looking forward to his position at Water District #63.

Boise Basin Refill: Director Gary Spackman reported on the proposed settlement agreement concerning the refill issue and said he expected it to be presented early in the 2019 legislative session. He has hopes that it will be adopted without any challenges. Gary also reported that he was made aware of the Barber Dam issues regarding reduction in flows to the river when they stop generation. This has a potential to interrupt flows to senior right holders and he has sent a letter to Ada County addressing these concerns.

Weather Modification: Rex reported on the current cloud seeding operations with Idaho Power including the amount of time ground generator's had operated and the amount of flares used by aircraft.

Columbia River Treaty: Chairman Case asked Paul Arrington to bring us up to speed on the current status of the treaty. Paul reported that negotiations with Canada were continuing but that not much information was being made public at this time.

New Business:

Minimum Assessments: Rex Barrie reported that the Advisory Committee had approved an increase to the minimum assessment from \$100.00 to \$150.00 and asked the water users to approve this increase. It was moved by Gail Glasgow to increase the minimum assessment to \$150.00. Second by Brian McDevitt. Motion passed with all in favor.

Adopt Resolution B thru J: Rex reported that a change was needed in the resolutions. Resolution I addressing wages and benefits should be removed so the Deputy Watermaster wages can be collected from general assessments. Brian McDevitt moved to strike Resolution I and to move Resolution J to I and to pass Resolutions B thru J. Second by Richard Durrant. Motion passed with all in favor.

Elect Watermaster: Mack Meyers moved to elect Rex Barrie as Watermaster for 2019. Second by Ron Platt. Motion passed with all in favor.

Elect Assistant Watermaster: Mack Meyers moved to elect Mike Meyers as assistant Watermaster for 2019. Second by Clinton Pline. Motion passed with all in favor.

Audit Report: Sam Rosti stated that the audit was prepared by Gary Merkle and reviewed by the committee and anyone wanting to review the audit to contact Rex for a copy. Motion to accept the Audit Report by Richard Durrant. Second by Ron Sedlacek. Motion passed with all in favor.

Guests:

Gary Spackman, Director, Idaho Department of Water Resources. Gary's report is listed above.

Paul Arrington, Idaho Water User's Association:

Paul reported on the Columbia River Treaty and introduced Morgan Howard as the new intern for IWUA. Paul stated that he wanted to thank the water users of District #63 for their continued support of the intern program. Paul reported that the Federal Government shut down has had

some effect on the land bill including a review of removal of the four lower Snake River Dams. The President of the U.S. would like this review completed by 2020. Paul also reported on the Columbia Basin Partnership and the Salmon discussions within that group. The Idaho Water Users Association annual convention will be January, 21 thru January 24, 2019.

Matt Anders, IDWR: Matt reviewed the 2018 water accounting and provided information on the storage account and operational losses to the system.

Peter Cooper, BOR: Peter reported on the current conditions in the basin and compared them to 2018. His report included end of year storage and current forecasted runoff in the basin.

Adjourn: there being no other business the meeting was adjourned at 3:32 P. M.
