Call to Order: Meeting was called to order at 1:05 pm January 12, 2009, by Carlene Smith, President

Water users in attendance: Dan Nelson-IDWR, Rocky Trail, Teresa McCallum, Jesus Hernandez D., Tony Ullrich, Carlene Smith, Margaret Reynolds, Ann Wilson, Yvonne Decker.

**Reading of Minutes:** Teresa McCallum read the minutes. Ann Wilson moved to approve, Tony Ullrich 2<sup>nd</sup>. Minute accepted as read.

#### **Election of Officers:**

**President:** Nominations were opened for President. Rocky Trail moved the President and Secretary remain the same. Tony Ullrich 2<sup>nd</sup>. Due to lack of people in attendance no one would accept the Secretary position. Carlene said she would not accept President unless Teresa took secretary. Teresa felt forced to accept nomination, however, stated this will be her last year. **Secretary/Treasurer:** 

*Watermaster:* Nominations were opened for the position of Watermaster. Teresa McCallum nominated Jose Villavicencio for the position of Watermaster, Rocky Trails 2<sup>nd</sup>. A discussion was held about the fact that Jose does not have any training for the position. We talked about asking Jim Allen again to take Jose around to familiarize Jose with the district. And show how to read the water levels. If that is unable to happen or possibly in conjunction with a letter will by written to the Department of Water Resources to ask for assistance in training. Should that not be able to happen, it may be possible that IDWR may have training in eastern Idaho. If so we will attempt to arrange participation in that class.

**Advisory Committee:** Rocky trails moved that advisory committee remain the same as last year, this was approved. The advisory committee is to be all users.

**Treasurer's Report:** Assessment for 2008 was \$552.78 w/ minimums amount billed was 636.55, collected was 636.55. All Water Users are current. Collected additional \$34.64 in interest on the bank account. Spent 260.00 on insurance, Watermaster salary of \$525.00. Postage of 22.71. Balance in the account is \$1,711.26 as of 12/31/08, Treasures report was accepted as read.

**Old Business**: Amendment to the By-Laws #1. In reading the minutes of the previous year it was noted that there had been an amendment proposed to the By-laws in 2007. The Amendment added Section 3 Article 6. In 2007 it was decided that it could not be acted on until the 2008 meeting. That it required more notification. So it was sent out with the minute for 2007. In the 2008 meeting it was decided that again we could not act on it because it was not noted in the premeeting notice. However, the amendment was again noted in the 2008 minutes.

Amendment to the By Laws #2. During the 2008 meeting an amendment proposed to add Section 4 Article 6. This was given notice in the minutes of the 2008 meeting and in the notice of meeting sent in December, 2008.

Amendments 1 & 2 and adoption of By-Laws for 2009 were so moved by Rocky Trails and 2<sup>nd</sup> by Tony Ullrich. Motion passed with no decent. Note: the new by-Laws included in this mailing with the new sections in Bold print.

**Previous year water report:** Teresa read the Watermaster report for 2008. There were 6 Call outs in 2208. On 4/12/08 Dirk took a look over the system. 4/19 was first call out to start water. 4/23 was a callout by Nate Jones for delivery. 4/30 was a callout by Paul Batruel at diversion. 6/02 was a callout by Rocky Trail to shutdown above diversion. Casa Del Norte called out on 11/01 to shut down stockwater. Moved to approve by Ann Wilson, 2<sup>nd</sup> Rocky Trail, motion approved

**New Business:** A discussion was held about the use of the term By-Laws, It was felt the in fact they should be termed Resolutions and that this should be considered a clerical error and renamed. Again, note the changes in the enclose copy.

Dan Nelson with Water Resources was given the floor to inform us about some upcoming changes to expect in the near future.

- 1. That perhaps there should be some consideration about combining Little Canyon Creek with the Cold Springs/Bennett Creek water district.
- 2. IDWR is in the process of creating a Mt. Home Ground water District that may or maynot include our area that is not determined yet. And that perhaps we may wish somehow be a part of that or attempt to access use of their Watermaster.
- 3. IDWR is also in the process of creating Snake River Water District, which would go from the Kinghill gauging station to the Idaho/Oregon border. This may or may-not include tributaries also still to be determined. But, can be expected in the next 2-3 years.
- 4. Dan presented a worksheet, to show that if we were unable to maintain a Watermaster, how much it would cost if the Department were to act as Watermaster. This was assuming 200 hours and minimum of weekly call outs for water season. The total was \$8089.00. This could go up if there were callouts not on our scheduled weekly review. See attached work sheet.

14 callouts at \$75/ea = \$1050.00

It was discussed that should we not be able to get Jim Allen to train Jose, and the Department would not assist with training on a personal request, and it was necessary to ask Jose to go Eastern Idaho if training was available. That we should budget \$200.00 to compensate for travel, meals lodging. This would also be considered a callout and would be compensated for that also. Suggestion was also made that perhaps JTS could be asked to help with compensation as it would benefit them to have a person trained in Head-gates and Weirs. All avenues to be explored and the \$200.00 will be at the discretion of the President and Secretary. Note after meeting and

during the Cold Springs/Bennett Creek meeting it was discussed to share in training cost if necessary. Rocky made motion for amendment to budget and moved for its approval, Tony Ullrich 2<sup>nd</sup>, Motion passed.

**Adjournment:** Meeting adjourned to 2<sup>nd</sup> Monday of January 2010; (January 11) – 1:00 pm, Glenns Ferry City Hall. Motion made by Rocky Trail, 2<sup>nd</sup> Yvonne Decker. Motion Passed

### ARTICLE I

### Name, Location, Business

SECTION 1: **Name:** The name of this organization shall be Little Canyon Creek Water District. "it shall be referred to hereinafter as "the organization".

SECTION 2: Location: 11204 N. Bar 21 Dr. Glenns Ferry, Idaho 83623 or with the current organization secretary.

SECTION 3: **Business:** This organization shall engage in the business of controlling and running the operations of Little Canyon Creek Water Districts 61D as prescribed by these By Laws.

### **ARTICLE II**

### Purpose

SECTION 1: **Purpose:** The purpose for which this group is organized is civic in nature to control the operation of irrigation along Little Canyon Creek. The organization shall be and is empowered to cooperate and work in compliance with the State of Idaho governmental agencies to achieve its purpose. This organization shall act as the primary controlling agency for Little Canyon Water District and shall promote just and equitable rules and controls in business, through the collection and dissemination of information, and through services that may be rendered in connection with subjects of general importance, through research and if needed direct action.

SECTION 2: **Limitations:** The organization in its activities shall be limited to insuring irrigators along Little Canyon Creek are in compliance with their water rights and controls are in place to enforce compliance as directed by Water District and the State of Idaho.

## ARTICLE III

# Membership

SECTION 1: **Eligibility:** Any person, firm, partnership, corporation/association, estate, or trust may apply for membership if they have water rights for taking water from Little Canyon Creek and agrees to conform to and abide by the By Laws of Water District 61D Little Canyon Creek and any amendments there to.

SECTION 2: Classification of Members: All active members in good standing shall be entitled to vote, to hold office, to serve on standing and special committees, to attend all

SCANNED JUN 2 3 2023 regular and special membership meetings, to have the privileges of the floor at such meetings and to participate in all referenda conducted by the organization. A member in good standing is one that is in compliance with all requirements of this organization and is current in any and all assessments made by this organization.

SECTION 3: **Membership dues:** The minimum annual membership dues for active members of this organization shall be reviewed annually by the board of officers and any proposed assessment shall be voted on by organization membership.

SECTION 4: **Voting:** Each individual member in good standing shall be entitled to one vote. Votes shall be by individual persons only, one vote person, and not by proxy unless done so in writing. Every firm shall designate a voting representative for each vote authorized.

SECTION: **Termination of membership:** Upon termination of any membership by death, resignation, sale or transfer of water rights in Little Canyon Creek or expulsion, the interests of such member in and to the property of this organization and his/her rights and privileges shall be forfeited. In the event of termination of membership, assessments shall not be refundable.

### ARTICLE IV

## Membership Meetings

SECTION 1: **Annual Meetings:** The annual membership meeting of this organization shall be held on the second Monday of January of each year at such time and place as may be designated by the President. At such annual meeting, the newly elected officers shall be installed.

SECTION 2: **Special Meetings:** The President may call such special meeting of the membership as he/she may deem necessary, and shall call a membership meeting upon the request of ten percent of the members in good standing.

SECTION 3: **Quorum:** Ten percent of the active members in good standing of the organization shall constitute a quorum for the transaction of any business at a membership meeting.

### ARTICLE V

### Officers

SETION 1: **President's Office:** The President shall preside at all meetings of this organization and perform all duties incident to that office. He/She shall, as he/she may deem proper, commend to the membership such matters and make suggestions as may tend to promote the prosperity and increase the usefulness of the organization. SECTION 2: **Secretary/Treasurer's Office:** It shall be the duties of the secretary to conduct the official correspondence, communication, and maintain an accurate record of the proceedings of this organization. The treasurer shall receive and disburse the funds of this organization. He/She shall keep all monies of this organization deposited in the name of this organization. All disbursements shall be made by check duly signed by the Treasurer and counter signed by the President if over \$500.00

SECTION 3: **Vacancies:** Vacancies occurring in the offices herein provided for shall be filled by interim appointment by a Resolution of the membership. The interim appointment shall be until the vacancies' term has expired.

SECTION 4: **Hold Harmless:** The Officers of this organization shall not be held personally liable for any of the actions of the membership of this organization unless criminal intent is shown.

SECTION 5: Term of officers: The term of elected officers shall be one calendar year.

### ARTICLE VI

### Representatives

SECTION 1: Any person or persons appointed to act as the official representative or representatives of this organization at conventions, hearings, or public meetings of any kind, shall so act only after receiving specific instructions from the President. Upon completion of such an assignment the representative(s) shall make a full report to the President.

SECTION 2: Watermaster as Representative of the Organization has the ability to set time limits for response to call outs not to exceed 48 hours.

SECTION 3: The Watermaster is to immediately notify the District Secretary when 10 call outs are performed. Then again when the budgeted callouts are reached, in any one year.

SECTION 4: The Watermaster shall attend the annual water meeting and any special meetings called by the President. The Secretary/Treasurer shall compensate the Watermaster at the current callout rate for any mandatory meetings.

### ARTICLE VII

# Budgeting

SECTION 1: **Fiscal Year:** The fiscal year of this organization shall be January 1 through December 31.

SECTION 2: **Budget:** The President shall constitute the Budget Committee and adopt a budget in December each year for the following year. At the annual meeting the President shall present the budget to the membership for approval and or adjustments. The President shall adjust and/or revise the annual budget to conform with any limitations or expenses created by changing conditions throughout the year. The Dues/Assessments shall be based on the estimated budget for the upcoming year. The Dues/Assessments shall be reduced by any remaining funds over \$1000.00 from previous years budget.

SECTION 3: **Dues/Assessments:** Each member shall be bill by the percentage of the water right held on Little Canyon Creek, with a minimum billing of 10.00 dollars. The amounts payable by each member as shown by the approved budget shall become due and payable on March 15<sup>th</sup> and that said amount, if not paid shall bear a penalty of 10% and shall bear interest from that date until paid, at a rate of 8 percent per annum. No member shall have the right to demand and receive water, and the Watermaster shall not

deliver to such person until the amount due and payable for such member as fixed by the budget has been paid.

### ARTICLE VIII

### **Amendments**

These Bylaws may be altered, amended, or repealed by one of the following:

- A. By the affirmative vote of two-thirds of the members of this organization at any regular or special meeting, provided the proposed action be presented in writing at the meeting to the membership preceding such vote, or notice in writing be sent to each member of this organization at least fifteen (15) days prior to such vote;
- B. By a two-thirds affirmative vote of the members entitled to vote there at, at the Annual meeting of the members, or any other meeting of the members called for that purpose by the President.

#### ARTICLE IX

#### Dissolution

On dissolution of this organization any funds remaining shall be distributed to the current members by the percentage of water rights held on Little Canyon Creek.

The meeting was called to order and minute read and approved. They re-elected the same officers, with the condition that this would be last year that Theresa McCallum would be secretary. All of the District water users were elected to the Advisory Board.

Jose Valensitio (Spelling?) was nominated as watermaster. Mr. Valensitio has no water delivery experience, so the District asked what kind of training was available. I informed them that the Department was considering watermaster training courses, but there was nothing definite at this time. I thought that there could be training course given in Eastern Idaho, but I wasn't sure where or when. The District agreed to ask former watermaster Jimmy Allen to spend a ½ of a day with Valensitio and pay Mr. Allen \$75 for his assistance. They also set aside \$275 at the discretion of the secretary and president to pay for travel to attend a watermaster training course if one was made available. I also suggested that they write a letter to John Westra to request personal training if the other two options didn't work.

The District voted in the resolutions with two amendments. These amendments were that the watermaster was to contact the Secretary when he reached 10 call outs and again when he reached the 14 call outs, which is all the call outs the District has budgeted for the watermaster. This would give the District time to call a special meeting to take the necessary action to ensure that money was available for the watermaster. The second amendment was that the District agreed to pay the watermaster \$75 or the cost of a call out to attend the annual meeting. This would give the watermaster incentive to attend the meeting.

The meeting was then adjourned.

Watermaster: Nominations were opened for the position of Watermaster. Teresa McCallum nominated Dirk Howard for the position of Watermaster, Rocky Trails 2<sup>nd</sup>. Then Dirk was asked to give a little information about him self. Dirk lives in Bliss and employed by Northside canal Co. as a Ditch Rider, and has been doing so for several years. There being no further nominations, nominations were closed. The nomination passed unanimously.

Advisory Committee: Rocky trails moved that advisory committee remain the same as last year, this was approved. The advisory committee is to be all users.

**Treasurer's Report:** Assessment for 2007 was \$623.27 w/ minimums amount billed was 706.20, collected was 706.20. All Water Users are current. Collected additional \$33.90 in interest on the bank account. Spent 297.00 on insurance, Watermaster salary of \$375.00. Balance in the account is \$1,847.78 as of 12/31/07, Treasures report was accepted as read.

Old Business: None

**Previous year water report:** Teresa McCallum stated that there were 5 callouts during 2007, 1<sup>st</sup> to start irrigation water, next by water resources regarding morrow resv. 3<sup>rd</sup> additional water to slick ditch, 4<sup>th</sup> by Nate Jones for more water, last was for stock-water on Berry Ranch by Casa Del Norte. A discussion was held that the users would like more information submitted as to the nature and outcome of the callouts. Dirk said he would give more details on the water record book. Also that the Watermaster report would be copied and sent out at the end of the year with the notice of the next annual meeting and other upcoming information such as amendments to by-laws.

**New Business:** Now with the use of By-laws by the District it is necessary to amend or approve the By-laws each year for the upcoming water season. There was a discussion that commenced regarding a proposed amendment to the by-laws. However, it was decided that a copy of the SCANNED

Rob Whitney with Water Resources stated the Cynthia Clark is now the new Dam inspector.

Teresa McCallum proposed a motion to request Jim Allen to accompany Dirk Howard on a call out at their convenience in order that Dirk could be train where the headgates are located for the district and that they should both be paid at the current call out rate. Motion seconded by Bob Hall, passed unanimously.

Bob Hall proposed a motion that the Watermaster attend the annual meeting, and the he should be paid the equivalent to the current callout rate. This was seconded by Rocky Trails and passed unanimously. This is where a discussion was held about making this a requirement in the bylaws as you will see in the attached proposed amendment for next year. Also it was decided that theses additional costs would be covered out of the reserve funds in the budget and could be replenished in the next annual meeting.

### BY LAWS OF THE

### 61 D LITTLE CANYON CREEK

### ARTICLE I

### Name, Location, Business

SECTION 1: Name: The name of this organization shall be Little Canyon Creek Water District. "it shall be referred to hereinafter as "the organization".

SECTION 2: Location: 11204 N. Bar 21 Dr. Glenns Ferry, Idaho 83623 or with the

current organization secretary.

SECTION 3: **Business:** This organization shall engage in the business of controlling and running the operations of Little Canyon Creek Water Districts 61D as prescribed by these By Laws.

### ARTICLE II

# Purpose

SECTION 1: **Purpose:** The purpose for which this group is organized is civic in nature to control the operation of irrigation along Little Canyon Creek. The organization shall be and is empowered to cooperate and work in compliance with the State of Idaho governmental agencies to achieve its purpose. This organization shall act as the primary controlling agency for Little Canyon Water District and shall promote just and equitable rules and controls in business, through the collection and dissemination of information, and through services that may be rendered in connection with subjects of general importance, through research and if needed direct action.

SECTION 2: **Limitations:** The organization in its activities shall be limited to insuring irrigators along Little Canyon Creek are in compliance with their water rights and controls are in place to enforce compliance as directed by Water District and the State of Idaho.

# **ARTICLE III**

# Membership

SECTION 1: **Eligibility:** Any person, firm, partnership, corporation/association, estate, or trust may apply for membership if they have water rights for taking water from Little Canyon Creek and agrees to conform to and abide by the By Laws of Water District 61D Little Canyon Creek and any amendments there to.

SECTION 2: Classification of Members: All active members in good standing shall be entitled to vote, to hold office, to serve on standing and special committees, to attend all ANNED

regular and special membership meetings, to have the privileges of the floor at such meetings and to participate in all referenda conducted by the organization. A member in good standing is one that is in compliance with all requirements of this organization and is current in any and all assessments made by this organization.

SECTION 3: **Membership dues:** The minimum annual membership dues for active members of this organization shall be reviewed annually by the board of officers and any proposed assessment shall be voted on by organization membership.

SECTION 4: **Voting:** Each individual member in good standing shall be entitled to one vote. Votes shall be by individual persons only, one vote person, and not by proxy unless done so in writting. Every firm shall designate a voting representative for each vote authorized.

SECTION: **Termination of membership:** Upon termination of any membership by death, resignation, sale or transfer of water rights in Little Canyon Creek or expulsion, the interests of such member in and to the property of this organization and his/her rights and privileges shall be forfeited. In the event of termination of membership, assessments shall not be refundable.

### ARTICLE IV

# Membership Meetings

SECTION 1: **Annual Meetings:** The annual membership meeting of this organization shall be held the second Monday of January of each year at such time and place as may be designated by the President. At such annual meeting, the newly elected officers shall be installed.

SECTION 2: **Special Meetings:** The President may call such special meeting of the membership as he/she may deem necessary, and shall call a membership meeting upon the request of ten percent of the members in good standing.

SECTION 3: **Quorum:** Ten percent of the active members in good standing of the organization shall constitute a quorum for the transaction of any business at a membership meeting.

# ARTICLE V

### Officers

SETION 1: **President's Office:** The President shall preside at all meetings of this organization and perform all duties incident to that office. He/She shall, as he/she may deem proper, commend to the membership such matters and make suggestions as may tend to promote the prosperity and increase the usefulness of the organization.

SECTION 2: **Secretary/Treasurer's Office:** It shall be the duties of the secretary to conduct the official correspondence, communication, and maintain an accurate record of the proceedings of this organization. The treasurer shall receive and disburse the funds of this organization. He/She shall keep all monies of this organization deposited in the name of this organization. All disbursements shall be made by check duly signed by the Treasurer and counter signed by the President if over \$500.00

SECTION 3: Vacancies: Vacancies occurring in the offices herein provided for shall be filled by interim appointment by a Resolution of the membership. The interim appointment shall be until the vacancies' term has expired.

SECTION 4: **Hold Harmless:** The Officers of this organization shall not be held personally liable for any of the actions of the membership of this organization unless criminal intent is shown.

SECTION 5: Term of officers: The term of elected officers shall be one calendar year.

### ARTICLE VI

# Representatives

SECTION 1: Any person or persons appointed to act as the official representative or representatives of this organization at conventions, hearings, or public meetings of any kind, shall so act only after receiving specific instructions from the President. Upon completion of such an assignment the representative(s) shall make a full report to the President.

SECTION 2: Watermaster as Representative of the Organization has the ability to set time limits for response to call outs not to exceed 48 hours.

SECTION 3: The Watermaster is to immediately notify the District Secretary when 10 call outs are performed. Then again when the budgeted callouts are reached, in any one year.

### ARTICLE VII

# Budgeting

SECTION 1: **Fiscal Year:** The fiscal year of this organization shall be January 1 through December 31.

SECTION 2: **Budget:** The President shall constitute the Budget Committee and adopt a budget in December each year for the following year. At the annual meeting the President shall present the budget to the membership for approval and or adjustments. The President shall adjust and/or revise the annual budget to conform with any limitations or expenses created by changing conditions throughout the year. The Dues/Assessments shall be based on the estimated budget for the upcoming year. The Dues/Assessments shall be reduced by any remaining funds over \$1000.00 from previous years budget.

SECTION 3: **Dues/Assessments:** Each member shall be bill by the percentage of the water right held on Little Canyon Creek, with a minimum billing of 10.00 dollars. The amounts payable by each member as shown by the approved budget shall become due and payable on March 15<sup>th</sup> and that said amount, if not paid shall bear a penalty of 10% and shall bear interest from that date until paid, at a rate of 8 percent per annum. No member shall have the right to demand and receive water, and the Watermaster shall not deliver to such person until the amount due and payable for such member as fixed by the budget has been paid.

ARTICLE VIII

## Amendments

These Bylaws may be altered, amended, or repealed by one of the following:

- A. By the affirmative vote of two-thirds of the members of this organization at any regular or special meeting, provided the proposed action be presented in writing at the meeting to the membership preceding such vote, or notice in writing be sent to each member of this organization at least fifteen (15) days prior to such vote;
- B. By a two-thirds affirmative vote of the members entitled to vote there at, at the Annual meeting of the members, or any other meeting of the members called for that purpose by the President.

### ARTICLE IX

### Dissolution

On dissolution of this organization any funds remaining shall be distributed to the current members by the percentage of water rights held on Little Canyon Creek.
