ANNUAL MEETING MINUTES WATER DISTRICT 170 – UPPER SALMON RIVER

Tuesday, January 24, 2017
Advisory Committee - 6:00 pm
General Meeting - 7:00 pm
Custer County Courthouse, Challis ID



The Advisory Committee met briefly prior to the general meeting. Richard Giampedraglia attended representing Thompson Creek Mining, who has not had a representative present for several years. The sub-districts are poorly represented at the WD170 meetings and more effort should be made to keep them engaged.

The group discussed the Advisory seats established for BLM and USFS, and considered eliminating those seats as the federal agencies don't appear to be as interested in District operation as in the past. The decision was to keep the seats intact for 2017 and reach out to members of these agencies during the upcoming year.

After a short discussion on the upcoming meeting and minor proposed changes to the resolutions, the Advisory meeting was adjourned.

The Annual Meeting of Water District 170 was called to order by Chairman Gary Chamberlain at 7:01pm. Twelve District members were in attendance.

Gary Chamberlain was nominated by Charlie Boge for meeting chair; seconded by Jeri D'Orazio and selected on a voice vote. Cindy Yenter was selected to act as meeting secretary.

Copies of 2016 minutes were distributed and reviewed and were approved with no objections.

Cindy Yenter gave a watermaster report which described her field activities in WD170 during 2016 and her goals and plans for WD170 in 2017. She also presented the snowpack report and a brief overview of other water activities in Idaho. That report is attached to these minutes.

The Watermaster made a statement reminding all water users that Stream Channel Alteration permits are required for work below the high water mark in all streams, even for emergency work in response to flooding events. Some discussion ensued regarding the Stream Channel Protection Program.

Chairman Chamberlain presented the proposed 2017 resolutions, which were unchanged from 2016 with the exception of date modifications in Advisory Committee Members and Budget section, and minor language changes in Watermaster Services. IDWR will continue to provide watermaster services, Cindy Yenter will be appointed WD170 Watermaster for 2017, and Water District 170 will continue to have a zero budget in 2017 and will not make assessments. Robert Boren made a motion to adopt the resolutions as proposed. Paul May seconded and the motion passed on a voice vote.



After a short discussion regarding the time and location of future meetings, next year's meeting is set for the fourth Tuesday of January, to be held in Challis at a location and time to be determined at a later date. After the Lemhi Basin is added to WD170, the meeting location might alternate between Challis and Salmon.

The meeting was adjourned at 7:25 pm.

Upper Salmon River Basin Support

- My IDWR position has been relocated to Salmon. I am operating the IDWR Salmon Field Office – the WD170 office is also officially at this location.
- Most of June and July spent moving and getting the office open and functional.
- Salmon Field Office is intended to provide enhanced customer support for all Upper Salmon water users, program support to other IDWR offices, and increased watermaster accessibility for WD170.

WD170 Activities, 2016

- Pahsimeroi NOVs all have been resolved with the exception of one headgate installation
- New Watermaster in WD71 provided training and support, filled in at the end of the season when she returned to school.
- WD71 and WD72D focused on better recordkeeping and updating watermaster field sheets
- Have been working on new water rights lists, and plan to provide all subdistricts with updated watermaster lists prior to this field season.

WD170 Goals and Plans, 2017

- Measurement compliance Pahsimeroi (WD73) groundwater diversions, non-subdistrict diversions, any other non-compliant diversions in other subdistricts.
- Diversion inventories of Lemhi (B74) ground water diversions.
- Begin diversion inventories in B75 (Salmon and tribs from Ellis to Middle Fork).
- Public information meeting and Hearing to add the Lemhi River water districts into WD170. These will be scheduled in the next couple of months.
- Separately, later in the year, IDWR hopes to hold a public information meeting for Basin 75 to talk about the eventual formation of subdistricts in this basin and inclusion into WD170.

Water News outside WD170

- The Salmon River downstream from City of Salmon has been designated a federal navigable waterway pursuant to the Rivers and Harbors Act. The impact of this designation is the loss of the irrigation exemption to the stream channel permit requirement. Not sure at this time how many diversions are affected. COE is working on a method to streamline the lengthy permitting process and grant annual permits to irrigators for necessary headgate maintenance.
- IDWR created water districts to administer ground water in the Raft River and Mountain Home areas.
- IDWR created a Ground Water Management Area over the entire Eastern Snake Plain Aquifer.

- In October, IDWR issued a comprehensive ground water measurement order requiring flow meters on all ESPA regulated wells (not including *de minimus* uses). The purpose of this order was to aid in implementation of the Surface Water Coalition settlement.
- In November, a new Ground Water District was created by water users in the Big Lost River area.
- The North Idaho Adjudication is in full swing.
- On Jan 17, 1017 IDWR Director signed an order curtailing ground water right holders with priorities junior to June 20, 1989 in the Surface Water Coalition call.
- We're having a great water year so far complete with ice jams and flooding.

ELECTION OF OFFICERS

Adopted 2007

Until changed by subsequent Resolution or otherwise altered by majority vote of the water right owners in their Annual Meeting or special meeting called for such purpose, it is herewith resolved that District Officers shall be elected at the end of each Annual Meeting allowing incumbents to conduct the entire meeting and Agenda business prior to any potential change(s).

OFFICER AUTHORITY Adopted 2007

Upon being duly elected by water right owner majority vote at their Annual Meeting the Secretary/ Treasurer shall, until replaced by subsequent majority vote of the water right owners in their Annual Meeting or special meeting called for such purpose, have full authority to sign on behalf of the District including, but not limited to, the District bank account(s). The Chairman and Watermaster shall also have alternate signature authority for the District bank account(s).

WATER RIGHT OWNERSHIP BY MULTIPLE PARTIES

Adopted 2007

Any water right(s) owned by more than one individual (or married couple) shall declare a single individual (or married couple) who shall represent all other owner's interests and be the primary contact with the District on relevant District issues.

WATERMASTER ACCESS

Adopted 2009

Until changed by subsequent Resolution or otherwise altered by majority vote of the water right owners in their Annual Meeting or special meeting called for such purpose, it is herewith resolved that all users shall provide for watermaster access to control structures and measuring devices. If the access is through a locked gate, the user shall, upon request by the watermaster, provide to the watermaster or deputy watermaster a key or combination to such locks.

ANNUAL MEETING DATE

Adopted 2007

Until changed by subsequent Resolution or otherwise altered by majority vote of the water right owners in their Annual Meeting or special meeting called for such purpose, it is herewith resolved that the Water district 170 Annual Meeting shall be the fourth (4th) Tuesday in January on a date, time and place to be determined at the Annual Meeting each successive year.

DISTRICT PAYMENT TERMS

Adopted 2007

- 1. Annual Adopted Budget payment shall be payable on or before March 1; any other billing within thirty (30) days following such billing; the postmark date will be considered the date of payment.
- 2. If not paid by April 1st the water user shall be charged in accordance with Statute 42-613 which provides for a late fee of 10% of the amounted and interest of 1% per month.
- 3. If not paid in full (partial payments shall not be acceptable) including Late Fee by April 1st, Treasurer shall so inform the Watermaster who shall immediately terminate water delivery to the water right owner who is in payment default.
- 4. Treasure must thereafter receive the original invoice amount, Late Fee(s) plus a \$25.00 Watermaster Service Fee before Treasurer shall advise the Watermaster who shall then again deliver the applicable right(s).
- 5. A returned or insufficient fund check shall require the Treasurer to so advise the Watermaster who shall immediately terminate the appropriate water delivery. All monies originally due plus applicable bank charges and any charges then resulting from unmet District payment terms must be paid in cash, cashier's check or money order before Treasurer shall so advise the Watermaster who shall then deliver the appropriate water right(s).
- 6. In the event payment in full is not received by the end of the then current irrigation season (or sooner if the Treasurer determines sale of the property and associated water right[s] is imminent), the Treasurer may, on behalf of the District, initiate legal action in Small Claims Court against the water right owner(s). Eventual recovery is to include costs incurred by such action as well as all other monies due.

Note: When a water delivery termination is imminent and there are others utilizing the same diversion that could be affected, those others affected shall, whenever possible, be advised of said delivery termination as soon as possible after the problem arises so they shall have the opportunity, if they so desire, to deal with the matter as they may deem appropriate before water delivery is reduced by the amount covered by the applicable right(s) being terminated

PROXY VOTING & SUBORDINATED WATER RIGHTS

Adopted 2007

- 1. In accordance with District Bylaws, proxy votes shall not be allowed "except that in the absence of the owner a right may be voted by another person present who has the use of the right for the ensuing season, such as a tenant, lesser or contract purchaser".
- 2. In such case(s) or whenever a right is subordinated and/or "worked" by anyone other than the owner a form adopted and provided by the District shall be completed and returned to the Secretary/Treasurer to remain on file throughout the term stating with whom such agreement exists, whether such voting right is granted, and/or granting authority to represent the water right owner on any other water issues that may arise during the irrigation season or balance of the agreement term to be recorded by water right owner with the County Recorder of jurisdiction. Seats may be added to or subtracted from the Water District No. 170 Advisory Committee in subsequent years depending on further revisions or expansions of the district boundaries to be determined as necessary. Each group represented may also select an alternate for each seat.

Representatives for sub-district areas will be selected during that sub-district's annual meeting. The sub-district will notify the WD170 watermaster of the representative(s) selected following the sub-district annual meeting. Representatives for the non-sub-district groups will be selected at the WD170 annual meeting. The Water District No. 170 Advisory Committee will meet as often as needed to address the structure, governance and operation of the district.

Re: Notice of Public Meeting for Modification of Water District No. 170 to Include the Lemhi River Basin and Modification of Existing Basin 74 Water Districts to Administer Ground Water

The Idaho Department of Water Resources (Department) intends to initiate steps to expand Water District 170 - Upper Salmon River Area (WD170) to include the Department's Administrative Basin 74 (the Lemhi River basin) situated in Lemhi County. The Department also intends to provide for administration of all water rights, including ground water, within the Lemhi basin and to propose other changes necessary for efficient administration and delivery of water rights tributary to the Upper Salmon River.

The basis for the Department's proposals includes:

- The Snake River Basin Adjudication was completed on August 25, 2014. Idaho law specifies that the Department shall create or modify water districts for the administration of water rights where the water supplies of such rights have been adjudicated.
- The Wild and Scenic Agreement (Agreement) was signed by the State of Idaho (State) and the United States government in 2004. The Agreement mandated the formation of WD170. The State has committed to the expansion of WD170 to include all rights in the Upper Salmon basin from the headwaters to the confluence with the Middle Fork Salmon River. Currently, WD170 includes water rights in the Stanley basin, Clayton area and East Fork Salmon River, Challis and Morgan Creek areas, and the Pahsimeroi River basin (see attached map).
- The Agreement requires the administration of water rights from both surface and ground water sources. No water district in the Lemhi River basin presently administers ground water rights.

The Department proposes to modify WD170 and the Lemhi water districts as follows:

- Expand the boundaries of WD170 to include all surface and ground water rights in Basin 74, with the exception of domestic and stock water rights as defined by Sections 42-111 and 42-1401A(11), Idaho Code, and rights used for in-stream watering of livestock as defined by Section 42-113, Idaho Code.
- Designate the following existing water districts as sub-districts of WD170: 74 Lemhi River, 74A Geertsen Creek, 74B Kirtley Creek, 74C Bohannon Creek, 74F Pratt Creek, 74G Sandy Creek, 74J Withington Creek, 74K Pattee Creek, 74M Agency Creek, 74Q Mill Creek, 74W Texas, Hawley, Timber, Junction, Bull, Jake and Canyon Creeks, 74Y Yearian Creek and 74Z Big Eight Mile and Lee Creeks The N N E D

Department does not propose additional assessments to Lemhi sub-districts by WD170, so long as each sub-district remains active, operates in accordance with Idaho Code, and the Department continues to be elected to provide watermaster services for WD170.

- Sub-districts in Basin 74 will be modified to include all surface and ground water rights within their respective boundaries and jurisdictional tributary streams, with the exception of domestic and stock water rights as defined by Section 42-111 and 42-1401A(11), Idaho Code, and rights used for in-stream watering of livestock as defined by Section 42-113, Idaho Code.
- Water District 74U Andrews and Slough Ditch will be dissolved. Water District 74U is operated as a lateral ditch by a lateral water users association and should continue to operate in this manner. The watermaster of Water District 74 Lemhi River will continue to deliver water rights from the Lemhi River to the head of the Andrews and Slough Ditches.
- Water District 74Y Yearian Creek is not presently operating as an active water district. This district must be reactivated or combined with another active district in Basin 74.
