## AGREEMENT FOR USE OF SCHOOL FACILITIES

THIS AGREEMENT, made and entered into this 14<sup>th</sup> day of April 2017

### WITNESSETH:

1. The District hereby agrees to provide the following school facility for use of the Lessee:

  - e. To follow the policies of Pleasant Valley School District No. 364. Any violation or wanton disregard of District policy will result in automatic forfeiture of future use requests.
  - f. Only the rooms/facility requested will be accessible.
  - g. District grounds/facilities will be adequately supervised during the authorized activity and care will be exercised to prevent any damage to District property and buildings, at the Lessee's expense. **All children present will be supervised during the entire time the grounds/facilities are being used; whether inside school buildings, on playgrounds, or surrounding school property.**
  - h. To leave the grounds/facilities in a condition equal to or better than when authorized for use and to pay for damages beyond "reasonable wear and tear".
  - i. To designate a person to represent the Lessee.
  - j. To hold the District harmless and to indicate whether the group has liability insurance coverage for the activity. Lessee must provide proof of liability insurance for the requested activity. Be it further understood that the District assumes absolutely no financial responsibility for any injury or accident, or lawsuit, etc. that may occur during the Lessee's tenure of grounds/facilities.

Re: Notice of Public Meeting – Creation of a Water District for Jordan Creek and Tributaries

The Idaho Department of Water Resources ("Department" or "IDWR") intends to initiate steps for the administration of water rights diverted in Idaho from Jordan Creek and tributaries to Jordan Creek by creating a new water district. The Department is considering this action because:

- 1. The Snake River Basin Adjudication ("SRBA") was completed on August 25, 2014. Idaho law specifies that the Department shall create or modify water districts for the administration of water rights where the water supplies of such rights have been adjudicated.
2. The Department has received complaints from senior water right holders on Jordan Creek that they are not receiving the water they are legally entitled to receive.

The Department has scheduled a public information meeting as follows:

Jordan Valley, Oregon 97910

The purpose of the meeting will be to inform water users of the requirements of a water district, the anticipated schedule for creation of a new water district, and to gather feedback. Department representatives will be on hand to answer questions.

The meeting will be conducted in a facility that meets the accessibility requirements of the Americans with Disabilities Act. Should you require special accommodations in order to attend, participate in, or understand the meeting, please contact the Department at least five days prior to the meeting.

A copy of this notice has been sent to all holders of water rights diverting surface water in Idaho from Jordan Creek and tributaries to Jordan Creek within Idaho.

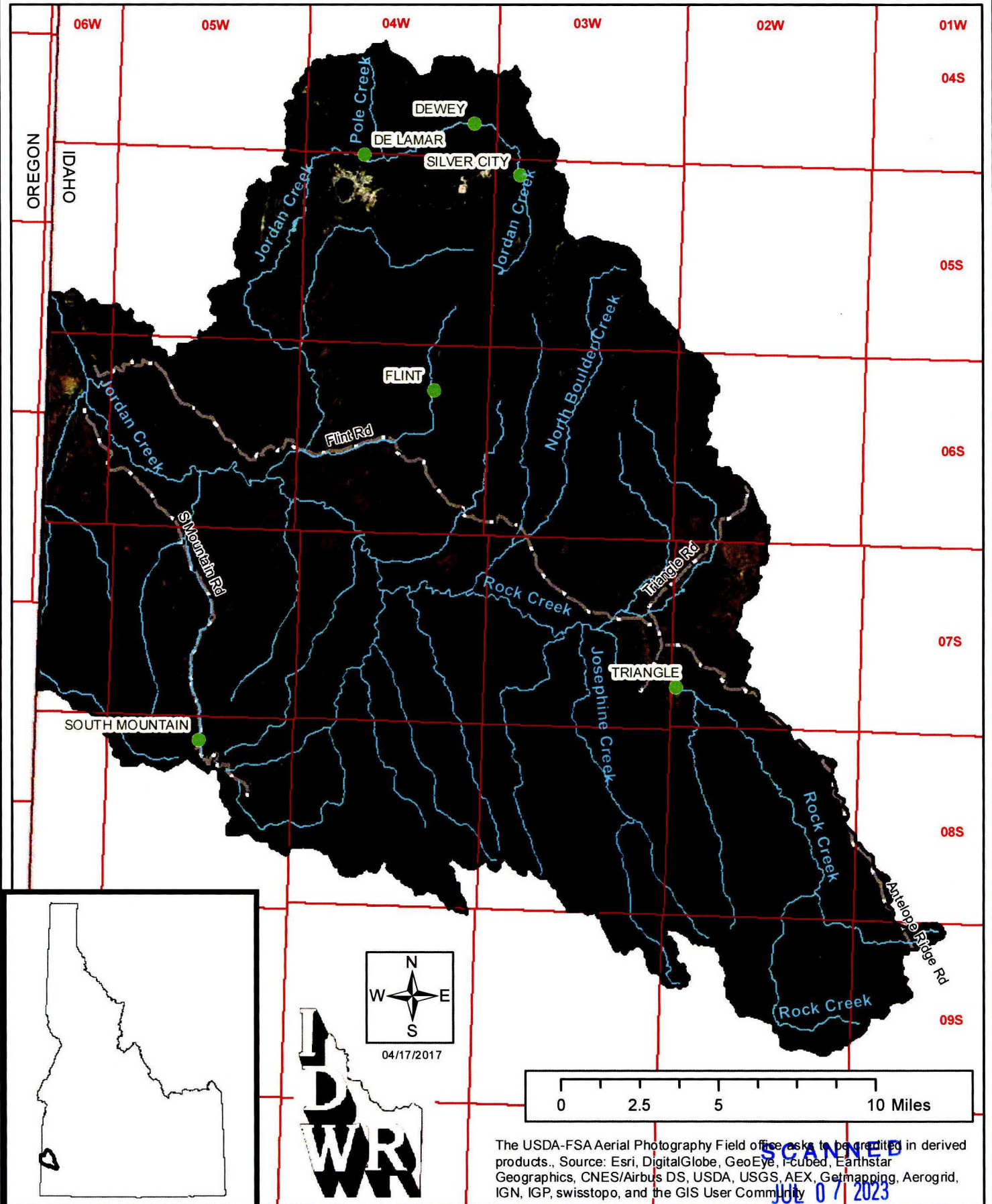
