The Secretary read the minutes from the 2016 meeting, Luther Cook made a motion to approve the minutes and Ron Davison seconded it. All in favor.

Luther Cook made a motion to keep all officers the same and Mike Davison seconded it. All in favor.

Luther said approximately 30 trees have fallen into the canal that will need to be cleaned out before we can turn water into canal. We need to look at the canal before we turn the water in.

Luther said we will also need a new set of planks for the canal head gate.

Next meeting will be held the first Tuesday in March, 1:00, 2018 at the home of water master Randy Davison.

The officers are as follows: Water master-Randy Davison, Chairman-Kenny Davison, Secretary-Sandy Davison, Advisory Board- Steve Ireland, Bill Davison and a representative from the Forrest Service. Credential Board- Ron Davison, Mike Davison, and Luther Cook. A motion was made and seconded to accept the officers.

Water master is to check with the secretary when called out. Water district will pay the Secretary when called out. Water district will pay the Secretary \$25.00 a year for expenses if the Water master is called out.
